

Dear State Treasurer, Governor, and Chief State Magistrate.

I am writing to request the appropriate USC 31. Garnishment Wage form to secure a financial debt claimed by the York County Men Justice Center Detention Department and the York County Magistrate's Office on Hwy. 5, East, York, SC.

In 2008, I received a Check for \$ 7,000,000,000. Seven Billion Dollars which was endorsed and placed in a long-term savings account. The Check was delivered by Senator Hillary Clinton of New York's Democratic Conservative Party nearly a year after the purchase of my securities by the United States Federal Government. My funds are presently sequestered and conserved by Court order by fiscal tech.

Due to the disorderly operation and undue process of the Sixteenth Circuit Judicial Venue; during a period of a Preliminary Federal Investigation in which I am subject under the subordination of Government Bonds, I must now issue warrants to withdraw financial holdings for a sufficient Criminal defense in which I am neglected by the York County Public Defenders Office, wrongfully imprisoned by the local publically Corrupted Leadership of York County's 46<sup>th</sup> District, and extorted by a wheel conspiracy of intra-Corporate association of foreign European Business Competitors in Interstate Commerce Trade Agreements with the State of South Carolina's Prison Industries under what I assume to be Corporate merger Contracts.

In the very near future the dissolution of partnerships through the winding up of businesses, will result in the crash of various business markets wherein persons are Contracted in Corporate Bond agreements, performing by assents of duress, unfair labor management agreements, and unfair Competition. Charges such as: Criminal Sexual Misconduct, Criminal Misconduct, Sexual Harassment, Sexual Assault, and tax frauds have been filed against persons of interest. Yet, information regarding both defendants and victims have been concealed during the Preliminary Investigation period and statute of limitation regarding appeals for persons formerly convicted yet still subject to Corporate Bond Contract obligations by nature of Commercial Broadcast Criteria. 
