Martha,

Due to the transfer of this program, there are two federal grants that would be transferred. The total federal award amount is approximately \$13,107,725 per year. During FY16, DSS would deobligate the unexpended amount from those two awards and this amount would be awarded to DEW by FNS. That amount is projected to be approximately \$11.6 million. DSS would also transfer to DEW approximately \$57,500 in General Funds and approximately \$27,812 in Earmarked Maintenance Fee revenue collected during SFY16. There are currently 17 TG positions and 1 FTE associated with this program.
