4. Copy of the SIS Appeals Process and conditions for appeal.
5. May SIS Providers direct bill to Medicaid for training and/or completing the scale?
6. Does SCDHHS have contracts with USC, Center for Disability Resources, now Byron Building Program, in reference to the Supports Intensity Scale? May we be provided a copy of the contracts?
7. Will the LAC Audit and a DDSN/USC conflict of interest impact the validity of SIS? How will DDSN and DHHS implement SIS while the audit is underway? Is it possible for DHHS to implement SIS independent of DDSN or USC?
8. Is DHHS currently implementing SIS? What is the current stage of implementation?
9. Will full scale implementation begin with the funding requested in the 2013-14 budget prior to the outcome of the pending LAC Audit?

I received your voice message. Thank you for responding to our efforts to contact Anthony Keck, Director, in reference to the Supports Intensity Scale (SIS). Your message asked that we let you know what information we were requesting.

Initially, our interest was who, what, when, where and how? What is SIS? Why choose SIS? How will SIS be funded? Who will do the evaluations? When will implementation begin? Where will implementation begin? The majority of our network welcomes a consistent, standardized assessment tool used by trained interviewers to provide a clear picture of an individual's needs. Therefore, we really want to learn about SIS. We also welcome Direct Billing and Targeted Case Management (TCM). We want to learn how SIS, TCM and Direct Billing will work together.

There have been two occurrences since our initial effort to contact Mr. Keck .

First, there's new Legislative Audit Council (LAC) Audit underway which involves "conflict of interest" between the Department of Disabilities and Special Needs (DDSN), the University of South Carolina (USC), Center for Disabilities Resources (CDR), now called Bryant Building Program, and it's director, David Rotholz. SIS is included in a bundled contract between DDSN and USC. Since the bundled contract may be included in the LAC Audit, we're hoping protocol will not prohibit you from providing us information.

Second, the proposed Executive Budget was released on-line just before Christmas. In the 2013-14 budget, \$600,000.00 is included for SIS as a Resource Allocation Tool. The Executive Budget states, *"This instrument is critical to the development of valid treatment plans, but also, the equitable allocation of the state's funds for those with special needs."*

DHHS is the "sole authority" for all Medicaid Home & Community Based Waivers. DHHS contracts with DDSN to administer waivers. DHHS also administers waivers. An example is the Community Choices Waiver. DHHS

maintains responsibly of care for all waivers. We're assuming that DHHS is also implementing SIS. At this point, we're interested in the mechanics of SIS, conflicts of interest, standard operating procedures, and the appeals process. We are hoping you can assist with the following:

1. Copy of the Supports Intensity Scale (SIS) Evaluation.
2. SIS Standard Operating Procedures.
3. How many hours of training, type and who is providing training for SIS? What are the qualifications to be an evaluator?
4. Copy of the SIS Appeals Process and conditions for appeal.
5. May SIS Providers direct bill to Medicaid for training and/or completing the scale?
6. Does SCDHHS have contracts with USC, Center for Disability Resources, now Byron Building Program, in reference to the Supports Intensity Scale? May we be provided a copy of the contracts?
7. Will the LAC Audit and a DDSN/USC conflict of interest impact the validity of SIS? How will DDSN and DHHS implement SIS while the audit is underway? Is it possible for DHHS to implement SIS independent of DDSN or USC?
8. Is DHHS currently implementing SIS? What is the current stage of implementation?
9. Will full scale implementation begin with the funding requested in the 2013-14 budget prior to the outcome of the pending LAC Audit?

We sent Anthony Keck three written requests (attached below) asking for assistance in reference to the Supports Intensity Scale (SIS).

We have been unsuccessful in our attempts to obtain information from DDSN. We requested assistance from Dr. Beverly Buscemi, Executive Director, and the DDSN Commission. Upon her invitation we attended Dr. Buscemi's October 15, 2012 advisory group meeting. The DDSN Advisory Group consists primarily of providers and/or organizations that receive funding from DDSN. Our representatives spent all day traveling to Columbia to attend the meeting, yet did not receive information about SIS. We sent a FOIA Request, and did not receive complete information.

The majority of our membership supports a resource allocation tool. Please request Mr. Keck to advise us if he is able to assist us in receiving information? If he is unable to assist, please refer us to an appropriate source. This week we learned that there is an Legislative Audit Council (LAC) Audit underway. It appears DDSN and USC are both included in the audit. DDSN has contracted with the University of South Carolina (USC) to complete SIS evaluations. With a pending audit, please advise if it's more appropriate that we contact the LAC?

I would like to ask for your help. You were employed by Louisiana Medicaid before coming to South Carolina. Louisiana was one of the first states to implement the Supports Intensity Scale (SIS) as a Resource Allocation Model (RAM). SIS has the potential of being an effective assessment tool. The creators of SIS establish that stakeholders must be involved from the beginning. The Department of Disabilities and Special Needs (DDSN) has entered into a June contact to implement SIS. Rather than involve consumers from the beginning, DDSN has chosen to limit and continues to limit the involvement of primary stakeholders.

Attached is a September 25, 2012 memo from Dr. Beverly Buscemi, Director of DDSN. The memo was sent to an advisory group she created. Her group is made up primarily of providers who receive funding from DDSN. According to Dr. Buscemi's memo, DDSN entered into a contract in June 2012 to implement SIS. SIS interviews with consumers are underway. Dr. Buscemi's memo was the first we heard of SIS. In her memo, Dr. Buscemi asks that information not be shared with our advocacy group or the general stakeholder community. A meeting is set for six weeks in the future, but only the limited, select group that is her advisory group may know about the meeting, and attend.

Two e-mails from independent disability advocacy groups were sent to Dr. Buscemi requesting information about SIS. She declined. Advocacy groups requested DDSN Commissioners to place SIS on their October agenda. On October 18, 2012 SIS appeared for the first time on the DDSN Commission Agenda under "New Business". Only one commissioner, Ms. Deborah McPherson, appeared to have an understanding of SIS. Commissioner McPherson represented SIS as a resource allocation model which had the potential to be an effective assessment tool.

Unable to obtain information from DDSN, we have turned to the SIS Web Page, the manual from American Association of Intellectual Disabilities, and information from other states. Louisiana has a Power Point and report available on-line.

As the creators of SIS envisioned, we would have liked to have been a part of the process from the beginning. Limited information prevents us from seeing the big picture. Limited information also makes people afraid. Especially when you

are being asked to complete the evaluation scale, and you don't know what it is. Based on your experience in Louisiana, may we request your help in learning about SIS, and how it can benefit families. We're hoping DHHS is promoting the use of SIS, and will assist us by providing access to information.

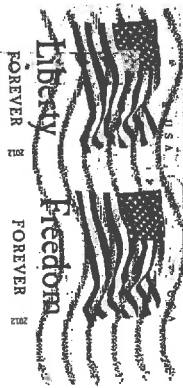
