Dear Mr. Drayton:


Your Freedom of Information Act request dated October 22, 2013 was referred to me for handling. You requested a copy of "recommendation letters in any form received by your agency from Senator Vincent Sheheen of Kershaw County or his staff.

The Human Resources Office and Director's Office have searched their records and found that there was one letter received from Senator Vincent Sheheen. However, at this time that letter is exempt from disclosure under S.C. Code Ann. §30-4-40(a) (3) (b).

If you like, we will continue the search for recommendation letters by requesting that each individual in a supervisory capacity in the agency check their records. We estimate the cost of conducting such a search will be \$1,400.00, therefore we are requesting a deposit of \$700.00.
