Chairman Gunnells stated for the record that both the Press and Banner and the Index Journal were notified of the meeting and that the meeting agenda was posted on County Buildings as required by the Freedom of Information Act.

## **APPROVAL OF MINUTES:**

- a) Councilman Thomas made a motion to approve the minutes of the April 11, 2005 county council meeting. Councilman Norris seconded the motion. The motion carried 6-0-0.
- b) Councilman Norris made a motion to approve the minutes of the April 15, 2005 Savannah Lakes retreat. Councilman Calhoun seconded the motion. The motion carried 4-0-2 with Councilman Davis and Vice Chairman Forrester abstaining.
- c) Councilman Thomas made a motion to approve the minutes of the April 16, 2005 Savannah Lakes retreat. Councilman Calhoun seconded the motion. The motion carried 4-0-2 with Councilman Davis and Vice Chairman Forrester abstaining.

- b) Second reading of an ordinance (05-12) to amend the FY 04-05 budget for Abbeville County by incorporating the unexpected revenues and the expenditure thereof for the employee Christmas bonus and the increase in insurance costs. Councilman Norris made a motion to approve second reading. Councilman Calhoun seconded the motion. The motion carried 6-0-0.

- b) A resolution (25-05) authorizing the County Director to transfer \$14,000 from account number 236-557-46520-7000 to account number 236-557-46520-72040 for the purchase of additional computers pursuant to the ordinance regulating the infrastructure development millage special revenue fund. Councilman Norris made a motion to approve the resolution. Councilman Thomas seconded the motion. The motion carried 6-0-0.
- c) A resolution (26-05) authorizing the Abbeville County Director to enter into a contract with DSP Architects, Inc., for the preparation of architectural plans for the Abbeville County Multi-Purpose Building. Councilman Norris made a motion to approve the resolution. Councilman Calhoun seconded the motion. The motion carried 6-0-0.
- d) A resolution (27-05) recognizing the accomplishment Ms. Patricia Gordon has given to the Planning and Zoning Department. Councilman Thomas made a motion to approve the resolution. Councilman Calhoun seconded the motion. The motion carried 6-0-0.
