Honorable Judge Rucker , I am the Maternal grandmother to the above mentioned child .You presided over the Richland Cty DSS case on the above mentioned date .My daughter, and the Mother of the child , is Jessica Mullikin.Her Court appointed Attorney was Lynn Hensley.I was present in the Courtroom that day and it was my understanding per your ruling that the child be returned to his Mother after an approved home study .The home study was performed on August 1st and approved by the DSS Caseworker. My daughter was informed the child would be returned home later that day or the next .It has been " one thing after the other "new" DSS requirements, paperwork, etc ..None of which to my knowledge You ordered .Ms Hensley , her Attorney has sent multiple demands to DSS to return the child to his Mother as recent as August 12th, The Gaurdian ad litem Delayne Morgan , and the " Gal " Attorney , Betsy Burton sent an email to DSS on August 12th inquiring as to why my Grandson had not been returned to his Mother and to do so .My daughter has been Completely Compliant and gone above and beyond what was ordered of her .She has diplomas from Parenting Classes , and others she was not Compelled by the Court to complete .She received letters of recommendation from her Instructors at Laradac .She had no negative urine test and a completely clean hair follicle test .She has a job , and a nice home that was approved via the DSS home study .I have called , and emailed the Governor's office , the DSS Constituency Office , Senator Katrina Shealy , Mr Reese Palmer Executive Director of DSS and multiple others pleading for help and intervention .Senator Shealys office is responding and Tiffany Brand of the Constituency Office at DSS is responding but it seems NO ONE knows what the " hold up " is or is accountable..They are all "looking into it " . Mr Palmer is not responding , nor is the Caseworker Marie Bartel , nor her Superior she suggested I call, a Ms Rhonda Mahoney .Today is day 17 since you ruled the child be returned to his Mother .I am deeply distressed, as is his Mother , concerned about the well being of the child , and confused as to why this is being allowed to happen .I do not know legally in what capacity you are allowed to respond or intervene but I am asking you do whatever you can within your power to bring this child home .He just turned 3 in July while still in Foster Care .You may reach me via my email or at 803 414 4410 ...Thank you ...I am forwarding emails I sent to Mr. Palmer , Ms Tiffany Brand, Governor Haley, and others
