Haley, Hello my name is Dennis Rodger Davis Jr. and I'm currently incarcerated in the South Carolina Dept. of Corrections, at Ridgeland Correctional Institution. The purpose of my correspondence is I am seeking your help madam. I will be eligible for parole 5/5/16 and I'm seeking a letter of recommendation that I be granted Parole and/or any other help you can or willing to give me in acquiring my freedom and getting home to my family! A little bit about myself is I'm 33 years old and I was born and raised in Rock Hill, SC. I am the proud father of 5 beautiful children, whom I love dearly and miss tremendously! I have never been on probation, nor parole, or community supervision. I'm incarcerated for distribution of marijuana, Prox. of a school zone, and simple possession of marijuana. I was sentenced to 125 months in 2014 for distribution of marijuana which is the dominate charge. I acquired these charges by going to get it for a friend that I later found out had gotten in trouble and chose to work with the YCNDEU. Even though I did not sale him the marijuana by SC law I still distributed marijuana by aiding, abetting and assisting him to obtain the marijuana. The drug unit asked me to set people up as well but out of fear for my life and family's I declined and thus prison sentence ultimately followed. I am not proclaiming to be perfect because in my lifetime I have made mistakes. We all make mistakes in life Governor

Halley, but what we do after the mistakes should be determined factors man. Well, since being incarcerated I have been working to better myself. I have learned how to fix small engines, a trade that I can and will use to help provide for my family, help my friends and society as well. I have a few business plans that I've been working on small business that I plan to make major in a few years time span. I have taken advantage of the library and law library to self educate myself. I have a GED and am currently pursuing my Work Keys Certification. I have also taken advantage of the Aft/NAft programs that have been offered at some institutions I've been too! And I am currently teaching an anger awareness class that is beneficial to my current society as well as the outside world, that I need your help getting back to. These few things are all tools that I've acquired, used and will continue to use to better the community, the lives of my family, and my life as well! All I ask is for a chance to show and prove! I have only 2 disciplines since my incarceration in 2014. Like I previously stated I'm not perfect but I'm striving for perfection daily! 2 disciplines in 2 years says a lot about me and my mentality. It screams I'm worth a shot Governor Haley! I choose to take advantage of my mistakes and grow as a man, a father, and a person. Not everyone back here does that. I have 5 children and I have not seen them since being incarcerated in 2014. I love them,

I miss them, and I deserve to be home with them.  
Infact my baby girl turned 11 years old today. I my-  
self came from a single parent home so I know what  
they are going through right now. I have multiple job  
options waiting for me, some local and some in Charlotte,  
NC as well. Mrs. Haley I need a chance will you help  
me achieve my ultimate goal and get home to my family?  
Governor I want to say thank you for your time and  
ear. I look forward to hearing from you and what-  
ever recommendations you may make on my behalf!  
Once again thank you for your time and God bless  
you from 1 american to another.
