The City of Columbia Police Department is interested in participating in your grant opportunity for Drug Take Back Boxes. We understand that the take back box is a reimbursable expense totaling no more than \$770 plus tax only if purchased off of the www.takebackexpress.com vendor.

The City of Columbia Police Department understands that the unit should include a double-lock door and be anchored to prevent retrieval and/or tampering of contents. It is also understood that the contents can only be removed by authorized personnel and off-premises by an approved vendor under the standards set forth by the Drug Enforcement Administration (DEA).

Aside from the costs of the box, it is understood that the Columbia Police Department is responsible for any and all continuing costs for the operation and maintenance of the receptacle.
