Thank you for your interest in South Carolina Certified Nursing Assistant (SC CNA) program. The South Carolina Department of Health and Human Services (SCDHHS) is in receipt of your formal request for the names and addresses of all certified nursing assistants that live in South Carolina. Our South Carolina Nurse Aide web site at www.promissor.com is available for all who want to verify the status of a SC CNA as required in the Code of Federal Regulations. 42 CFR §483.156(d) specifies what information must be made available to both the public and nurse aides. That information is accessed by name or unique identifier provided by the CNA to a prospective employer. We do not release the names and addresses of the aides on the registry, as we believe that information is exempt under §30-4-40(a)(2) of the South Carolina Freedom of Information Act.

South Carolina requires 80 hours of training for nurse aide candidates. The hours follow the national curriculum guidelines. Medicaid certified nursing facilities are required to provide continuing education units but continuing education units are not required to maintain nurse aide certification. A list of the Medicaid certified nursing facilities is available on the South Carolina Nurse Aide web site.
