Senator Danny Verdin contacted this agency on your behalf regarding prescription assistance for you and your son.



If you receive Medicare Part A or B it may be beneficial for you to join a Part D prescription drug plan if you have not already. You may contact Insurance Counseling Assistance and Referrals for Elders (I-CARE) at 1-800-868-9095 for help determining the Medicare prescription assistance available to you.

If you meet certain income and resource requirements, you may be eligible for Medicaid assistance that would be secondary to Medicare. Enclosed is an application if you wish to apply. You may also apply in person at the Laurens Medicaid Office: 93 Human Services Road, Clinton, SC 29325. Also enclosed is information on prescription assistance programs that may be helpful to you and your son.
