Nicole,

I trust that you will reply favorably to Mr. Bob Quinn regarding the April 1, 2015 speaking engagement for Governor Haley at Summerville Rotary Club.

Coincidentally, I have been having friendly conversations with a new firm that just expanded into North Charleston, SC from the UK. (See attached press release on Moneypenny.)

I had the good fortune to share a beverage and meal last night in Charleston with Ms. Rachel Clacher, one of the company Directors who still resides in the UK. She told me that they are hoping for – and expecting – meteoric growth in the USA as they have experienced in the UK over the past several years. In fact, I believe the objective was to bring on an additional 600 employees within the next few years. (Your office can confirm this number later with Moneypenny directly.)

Since Mr. Bob Quinn confirmed that April 1 works for the Summerville Rotary Club to host the Governor, I had a phone conversation with Mr. Toby Diggins (one of the US Directors here running the North Charleston USA operation for Moneypenny) and specifically asked him whether Moneypenny had any contact with Governor Haley's office before, during, or since they set up shop here (which happened only recently). He has advised that he has (1) not yet had any contact with the Governor's office to date and (2) would enjoy meeting the Governor. Therefore, I will plan to bring him to subject Rotary meeting as my guest so that they can at least say hello... As I know Governor Haley enjoys personally meeting folks who invest in our great State and do things to help foster job creation and grow our economy, etc.

As Moneypenny grows in the USA, I think it would also be beneficial for the Governor's office to direct them to the SC's Commerce department because, assuming they do add on a significant number of employees (which I believe they will) over the next couple of years, I would like for them to stay in South Carolina instead of being tempted to move away, etc.

Anyway, if you could please "put a bug" in the Governor's ear that Mr. Toby Diggins of Moneypenny will be in attendance on April 1 and he looks forward to saying hello to her, I'd appreciate it. Who knows – Maybe she'd like a photo op with Mr. Diggins since he represents direct foreign investment into our State?
