This is the first response I have received back from you.

Here is the following time line and every email I have receive from you which was the only on from 08/31/2016, so no you never responded.

I received this from on 08/31/2016; so I response then on 09/01/2016 I was forwarded an unopenable email from you by way of Investigator Brown. If you have a complaint against Deputy Bazzle, please send your emailed complaint to bandrews@spartanburgcounty.org for review. Thank you.

On 09/02/2016- I sent you the following with no response.  
Did you receive my email?

So my question is what course of actions has taken place since officer Bazzle inappropriately used his authority to determine that he was placing custody of my child to Theresa Jankowski, of which is beyond his authority. That is not the process that should have taken place. So in meantime they continued to coach my ADHD daughter. Even office Bazzle stated he could tell Jade was an attention seeker. I was told by officer Bazzle of which I have witnesses that heard the whole conversion that I was to have no contact with my daughter for which he cannot make that decision either (that is above his authority) as this was not an emergency removal nor was there a safety plan in effect of which a safety plan is not worth the paper is written on(my court order over rides DSS and officer Bazzle. I should have never been told I could not come get my daughter or talk to her. My husband was falsely accused and then I was included as well. You allowed two people to make false reports against my husband and you sit back and do nothing. Because of officer Bazzle's poor judgement and complete lack of common sense to know Jade was being abused caused my not to be protected, we had to go through pain.

You try crying because you are scared your kids a 9 year severe ADHD(which no how to handle her) and your 2 year old are going to get placed in foster care because of some lie a dead beat dad coaches his daughter to say through fear. Other people would not know or be able to deal with Jade and too often lately 2 years are dying in foster care. I have never been away from kids.

Both investigations with Spartanburg County and DSS were unfounded, but the damage was already done to my family. Why is David Lawson and Theresa Jankowski not having to pay restitution from making false police reports.
