Re: Records provided in response to *The State's* Freedom of Information Act request for emails related to the Confederate Flag.

Dear Jamie,

Recall that, due to the widespread, national public interest of the underlying issues, our office chose to reduce the cost of copying records from 10 cents to 5 cents per page and to waive in its entirety the cost for staff time to search and compile records as is allowed by Section 30-4-30(b) of the South Carolina Code of Laws (a reduced charge is appropriate where waiver of the fee is determined by the agency to be in the public interest).

Previously, our office estimated that the total cost to produce *The State's* request would be \$166.70 for which a deposit of \$100.00 was required to proceed. Enclosed is a copy of the check for the deposit of \$100.00 submitted by former employee Andy Shain. Accordingly, the remaining balance of \$66.70 is owed to our office. 


