She stated that several times he told her that he was going to kill her as he struck her in the head with a firearm and while pointing it at her head. She stated that at different times he would unload and reload the firearm magazine to further intimidate her into believing he was going to kill her. She stated that he told her she was allowed to go, but before she left, he wanted to have sex with her. She stated that when she told him no he started hitting her again, so she gave in to him allowing him to have intercourse with her.

The above information was revealed through the investigation of Detective Alexander. He is a witness to prove the same against the form of the statute and the peace and dignity of the State of South Carolina.
