Dear Senator Graham, I am writing to you about my son. His name is Logan, he is 22 years old and has Autism. He is the biggest blessing, and we love him so very much. He has come so far, and in fact wants to go further, but since graduating from the South Carolina School for the Deaf and Blind he has had nothing to do, but stay home. I can see a regression in his social skills, and his physical condition. We have been placed on a Medicaid Waiver waiting list, and his number is over 3000 which means we have to wait 5 years in order for him to qualify for any kind of day services or supports. I feel so helpless, because everyday he ask me if he is going to be a worker. He wants desperately to be a functioning part of society. Autistic people are often overlooked when it comes to jobs because of the stigma of negative behaviors, but I know this about those with ASD, they don't lie, steal, and what you see is what you get. I have never asked for help before, but I am asking!

for my son's sake. He deserves to be a part of this world, and to be able to pursue life to its fullest instead of wasting away in front of the TV at my parents house because we have to work. I would give anything to be able to stay home with him and design a program for him. We would volunteer at the hospital, nursing homes, and I would have him out and exploring jobs and possibilities, but unfortunately that is not an option. The next best thing is to get him into a day program here in Spartanburg, but sooner than later. I appreciate your looking into this for him.

On your behalf, we have contacted the South Carolina Department of Disabilities and Special Needs (SCDDSN) who has responsibility for serving adults with autism, and provides day to day operations for the Intellectual Disabilities and Related Disabilities (IDRD) Medicaid Home and Community-Based Waiver program, which offers a wide array of services for individuals residing in the community or needing residential placement.
