SCDEW has failed to provide job opportunities even though well qualified as performing required skills with an excellent performance record.The US EEOC in Greenville, SC failed to provide justice in the first complaint filed against SCDEW claiming to be discriminated by being blackball. I received verification from SC Judicial Court System stating my application has been Barred from Applying as a legal

representation of an employer within the state of South Carolina I contacted Gov. Haley Office numerous times seeking assistance from her but all my attempts were ignored. SCDEW sent a letter stating they have no interest in me and not to contact them which was also provided in a telephone call by Kerry Paul of SCDEW SCBCB and SCDEW was shock that I had been provided verification of Barred From Applying therefore both parties issued written stating an error that will be corrected after being contacted about the warning applied to my application to prevent employment opportunities. USEEOC decided to send my second complaint to SCHAC for investigating SCDEW,SCBCB and SC Gov. Office which should have never been since one state agency would be reviewing other state agencies. SCHAC was confident in investigating my complaint of Barred From Applying therefore determining it was applied intentionally to harm conducted by Investigator, Sharon Dorn. SCHAC denied access to investigative documents regarding Barred From Applying which US EEOC had to know their policy pertaining to retrieval of records. SCHAC did not find SCDEW,SCBCB and Office of SC Gov. guilty of any employment violations. I was not allowed to address SCHAC Board since a board member made the final determination. I was treated like a common criminal just because my attendance at a public meeting under the authority of SCHAC Director, Raymond Buxtion. USEEOC completed a weight review by Renee Grube which agreed with SCHAC findings even though I had been intentionally illegal Barred From Applying to prevent employment opportunities, false accusations of harassment with threats of calling local law enforcement to further harm and claiming blackball in my first complaint filed with US EEOC. The provided information give just a glimpse of deliberate actions by SCDEW,SCBCB,USEEOC and SC Governor Office.

The following actions verifies employment discrimination, retaliation,slander,false charges then what is illegal according to state and federal laws. I am still seeking justice.
