

Dear Senator Graham:

My name is Sharon McGovern; my SS # is 260-29-8269. My birthday is May 23rd, 1960. My current address is 112 Union Cemetery Road, Apt # 627 Hilton Head Island SC, 29926

I recently contacted your office concerning getting help as to why I have been denied Medicaid and SSI. I am trying to find out the status of my SSI. I spoke with the Medicaid office this morning and was informed that I did not qualify for Medicaid, because of income limits.

Senator Graham, My 14 yr. old son and I receive 840.00 per month from my husbands death of cancer at the age of 32. The income limits for SC Medicaid of 560.00. So therefore I do not qualify. How are two people expected to live off of 560.00 per month? We are having a very rough time right now due to me not working. Without help from local resources we would not be able to pay our rent. Life before cancer was not this way for us.

The best way to describe my situation would be to ask you to visit the website listed here. I did a story on healthcare and the uninsured with CBS news. It aired this past Sunday. <http://www.cbsnews.com/video/watch/?id=4546226n>.

On the day I did this interview I was having what I would call a good day. The people from CBS were wonderful and understanding.

I currently am in remission from cancer. But have to go back to MUSC on November 4th to have scans and pray that I am still in remission. I have been in remission for 6 months. During the time I was going through treatment I lost my home and everything I owned, and was homeless for 3 weeks., I now live in a small apt. with my son and am quite blessed to still be here. I am unemployed at this time due to Post Chemo pain and my illness.

I would like for you to please try and help me with getting qualified for Medicaid. I spoke with the person that handles Medicaid applications this morning and she told me that it is

quite sad when people like me that deserve this service is denied, but others get it right away.

I would also like to know if somehow in the future we can try and change our limits and qualifications for Medicaid in SC. So many people do not get these services that need them. And they are honest hard working people that fell on hard times. As I did.

If you could please look into this matter for me it would be greatly appreciated.

I did a clinical trial at MLJSC that saved my life, but due to lack of insurance I had to do all of my treatments without a port. Now I have no veins left. I also had to stay home for the whole entire time due to low blood counts from treatment. I could not get the shot that would bring my counts back up because it cost \$10,000.00 per shot. I am thankful to be alive and here writing this letter to you but not sure I will ever get over the pain and mental issues this past year has caused me.

Dear Ms. McGovern:

Senator Lindsey Graham asked our agency to respond to your concerns about Medicaid eligibility and your healthcare needs.

As you are aware, your current family income is above the allowable limit for the Low Income Families program. Income is based on gross earnings and does not allow deductions for taxes, utilities, car payments or other living expenses. Fortunately, coverage for your son, Shane, will continue under the Partners for Healthy Children program.

Thank you for your opinion regarding Medicaid income limitations. Medicaid eligibility is based on federal and state financial and categorical guidelines. Determining appropriate program requirements and those families that have the greatest need is always challenging. Budget constraints are also a major factor.

Your letter also mentions that you applied for coverage through the Social Security Administration's Supplemental Security Income (SSI) program. Individuals eligible for SSI automatically receive Medicaid benefits. To inquire about the status of your SSI application, please contact the SSA at 1-800-772-1213.

Enclosed is information on other programs and organizations that can assist residents in South Carolina with their healthcare needs, prescriptions, and inpatient hospitalization.
