AFFIDAVIT

Personally appeared before me, a magistrate of this County, one B.M. Goldstein who, first being duly sworn, deposes and says

Everette Rashad Duffy

did within Charleston County and this State on or about the 9th day of May 2016 violate the criminal laws of the State of South Carolina in the following particulars:

Violation of State Code 16-3-600(B)

Assault and Battery of a High and Aggravated Nature

The affiant states that there is probable cause to believe that the defendant named above did commit the crime(s) set forth, and that such probable cause is based on the following facts:

That on 05/09/2016 at approximately 23:45hrs. the above named defendant did knowingly, willfully, and unlawfully violate statute 16-3-600(B) Assault and Battery of a High and Aggravated Nature by the following particulars.

That the defendant did knowingly and willfully and with criminal intent did physically assault with his hands the victim Derrick L. Porter B/M, Age 28 while incarcerated at the Al Cannon Detention Center located at 3691 Leeds Ave. North Charleston, S.C. Both the defendant and the victim were being held in the same cell for independent charges when they got into a verbal confrontation about the victim's family members. During the confrontation the victim was struck by the defendant with his hands and thrown to the ground against the concrete floor causing serious bodily injury. The victim sustained four broken teeth, facial injuries to the bones in his face, and fractures to his skull. He was transported to MUSC where he is presently in the intensive care unit being treated for the injuries. The detention officers at the facility spoke with the above named defendant after being summoned to the cell, and he voluntarily admitted to them that he committed this assault.

That the above information is true and believable based on the investigation of Det. B. Goldstein of the Charleston County Sheriff's Office who is able to prove the same against the form of the statute in such case made and provided for against the peace and dignity of the state.
