To: State of South Carolina Governor, Nikki R. Haley

I stand with D. James Kennedy Ministries and many concerned citizens across our great state in urging you to protect the privacy of children and women using school and public restrooms, showers, and locker rooms.

While we certainly agree that transgendered individuals have civil rights, these are not special rights, and their civil rights are not superior to the rights of others.

We have sympathy for those who are suffering from gender identity confusion. However, the solution is not to give exceptional LGBT "rights" to transgendered individuals; rights that would override the rights of others to expect privacy and safety when using public restroom, shower, and locker room facilities.
