**SCDRO ISSUES HOUSING AWARD LETTERS FOR OCTOBER 2015 STORM**

**Columbia, S.C., February 1, 2017** – The South Carolina Disaster Recovery Office (SCDRO) has released 44 award letters as of January 31, 2017 for the repair or replacement of homes affected by the October 2015 Storm. Award letters notify citizens that they have been accepted into the program. The letter also lists the next steps the citizen must take to move forward.

Once approved, it is up to the citizen to decide if he or she will participate in the program. SCDRO protects the personal information of the citizens we serve and will release only the county and zip code for households served by the program.
