Danny,

Thank you for the phone call and your time.

Attached is the letters from three years ago that Grooms, Verdin, and Campsen sent to USC. Also attached is Pastides' response where he brushed all three aside. After this, bad media coverage hurt Pastides, and USC's lobbying efforts were not present when we tried to amend the law. We tried to amend the law in 2015, it passed the House and died in the Senate. Grooms directed me to meet with Clemson's lobbyist before the committee meeting. We were prepared to cut the current required "one year," in half to "three credit hours," Clemson would not agree to this. They wanted the "at least one year," amended to "at least once," without defining what "once" means.

That's my reasoning behind this draft letter. Please edit how you think is best, but keep it strong.
