Danny, Attached is a spreadsheet for you to review. The top shows actual spending over the last 5 years for the Administration Line Items. Below that is this fiscal year's budget allocation. Next to that is what Ken and I have discussed as the possible budget changes for next fiscal year. The unclassified is the salaries. The changes to that item are based on what we currently have and an additional \$55k. I was originally thinking \$45k for the additional amount but \$55k makes more sense when you take the total (\$240k) and divide it by the 5 FTEs, at \$48k per FTE. At \$45k in additional salaries it left each FTE at less then the Lieutenant Governor is statutorily paid. Reducing the Other operating Expenses by \$30k makes sense when you look at the historical expenditures.

Below those are the cost estimated for interns (prepared by me so they may be off by a few dollars). And finally below that is an estimate for a part-time assistance during session at \$15 per hour.

Ken has also just spent me an update and with carry forward dollars from last year there is over \$85k in the operating expenses fund, so if this fiscal year we needed a little room for interns and/or a part-time assistant, this would give us some flexible dollars to work with.
