Katherine,

The State sold 9 series of State General Obligation Bonds last Thursday and we plan to close the transactions on March 1. The vast majority of the issues involve the refunding of existing debt for debt service savings; the two new issues for new projects are Economic Development Bonds for Volvo and State Institution Bonds for MUSC.

We plan to obtain the Treasurer's signature for closing documents on Wednesday (2/17) afternoon. In accordance with past practice, we would be happy to drop documents at your office either late Wednesday (after 4:30 p.m.) or early Thursday morning to allow the Governor to sign the documents at her convenience. If we could retrieve the signed documents by the following Wednesday (2/24) or Thursday (2/25) that would be very helpful. Please let me know if this arrangement is suitable. We will make ourselves available should you have any questions.
