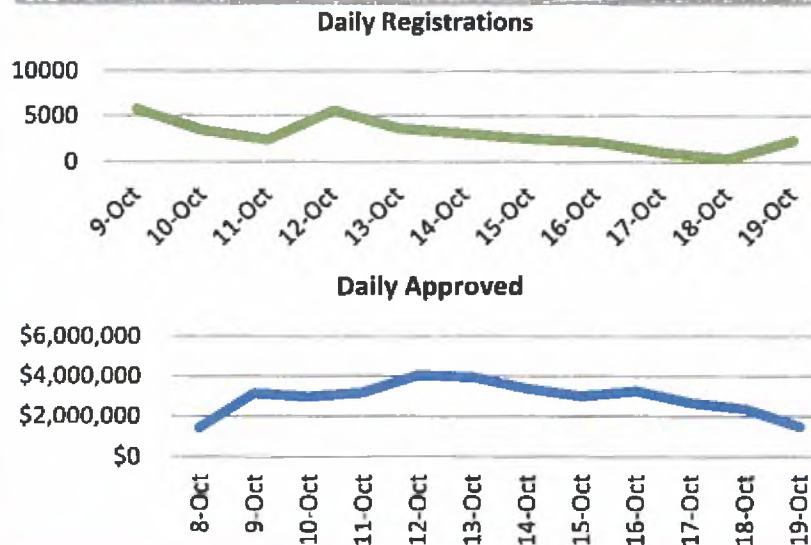

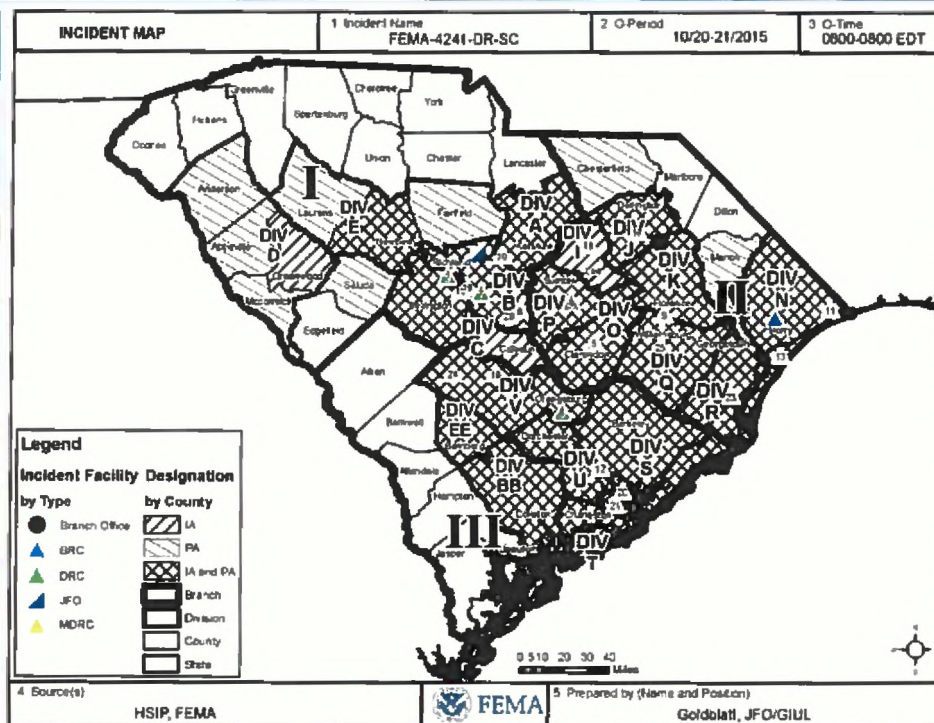

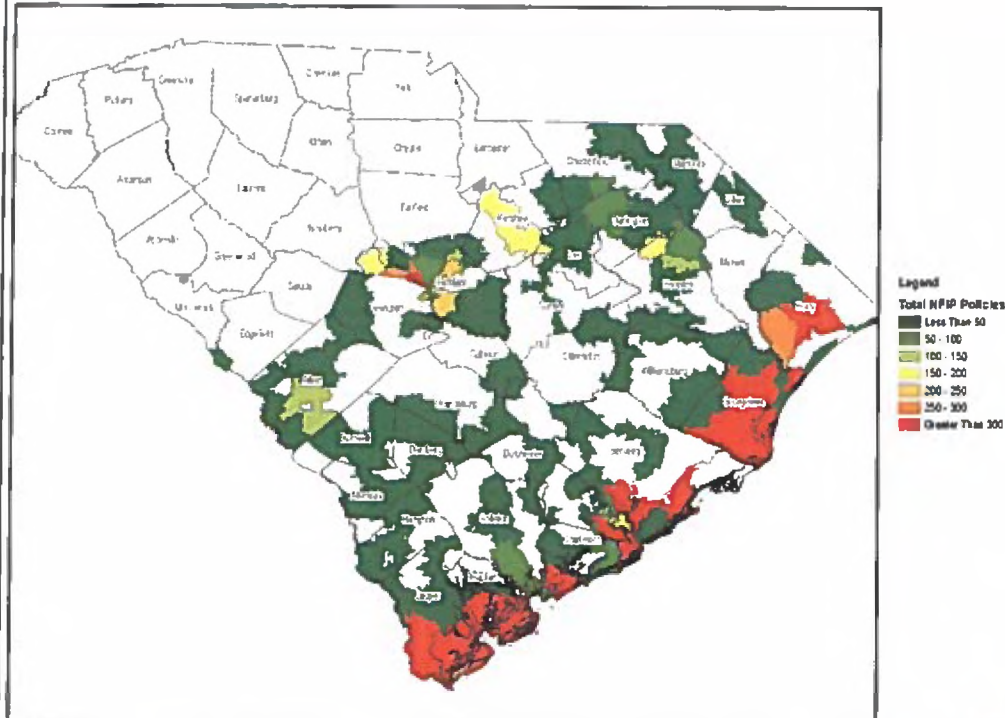

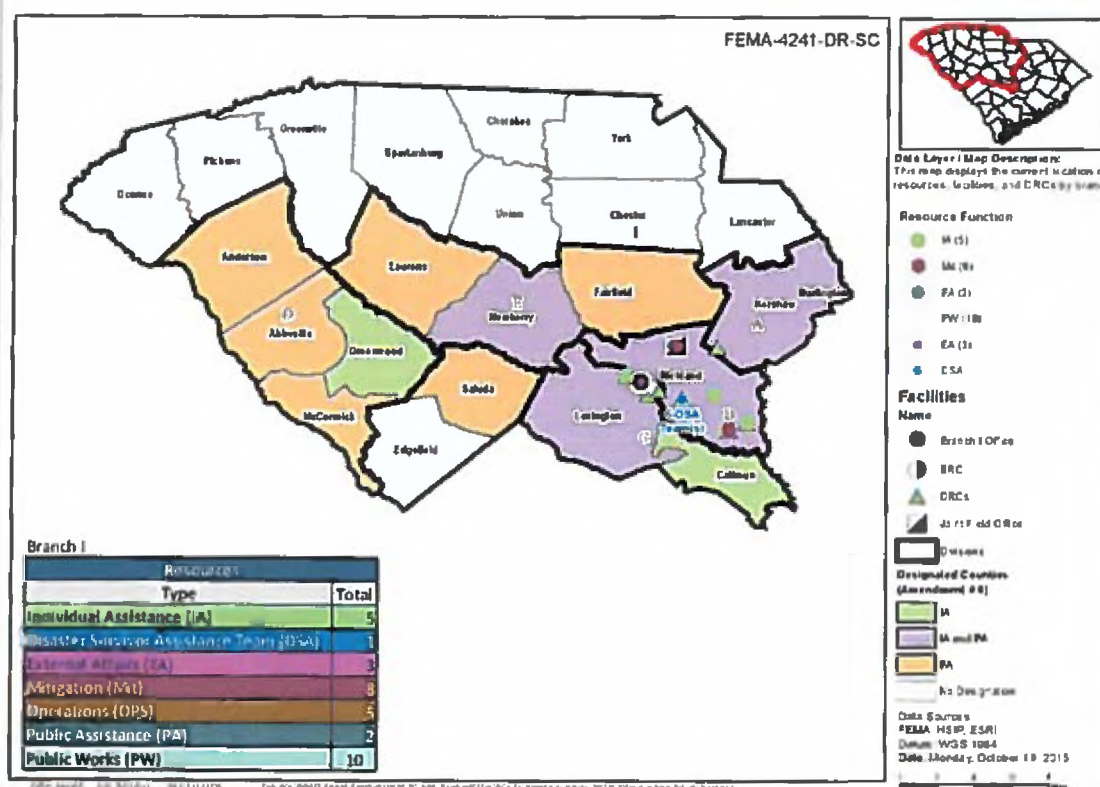

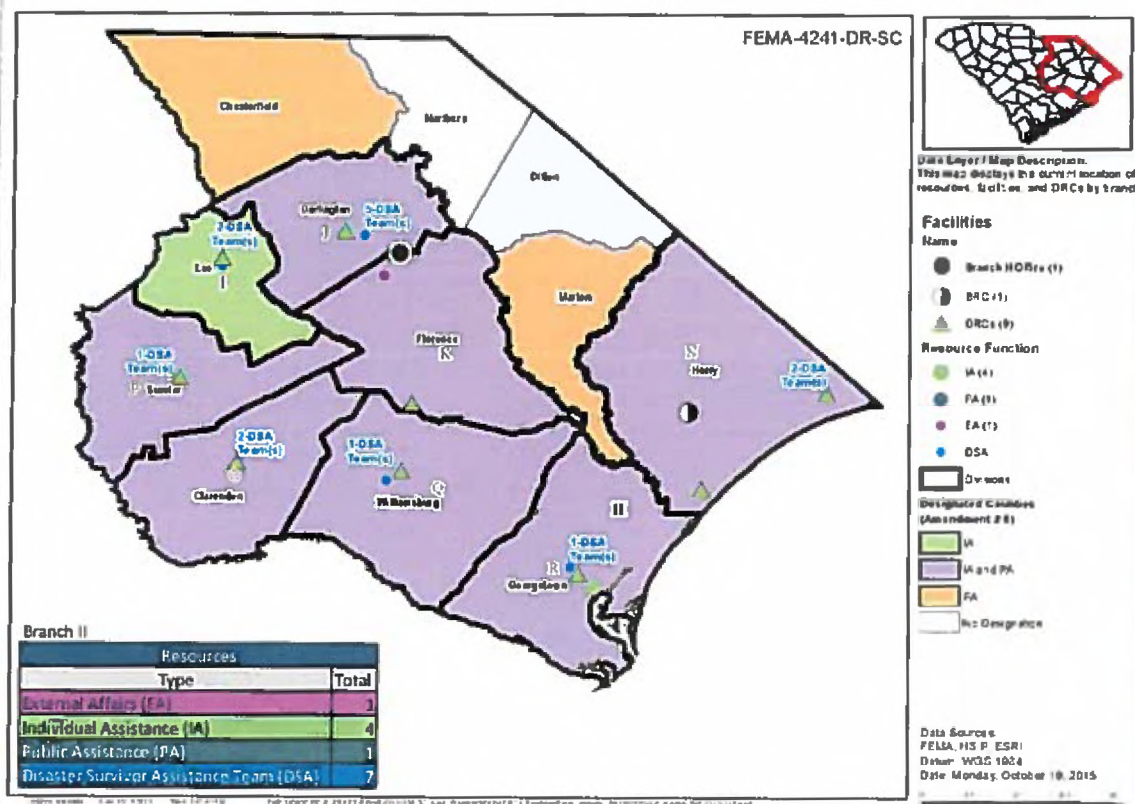
Dam/Columbia Canal Update

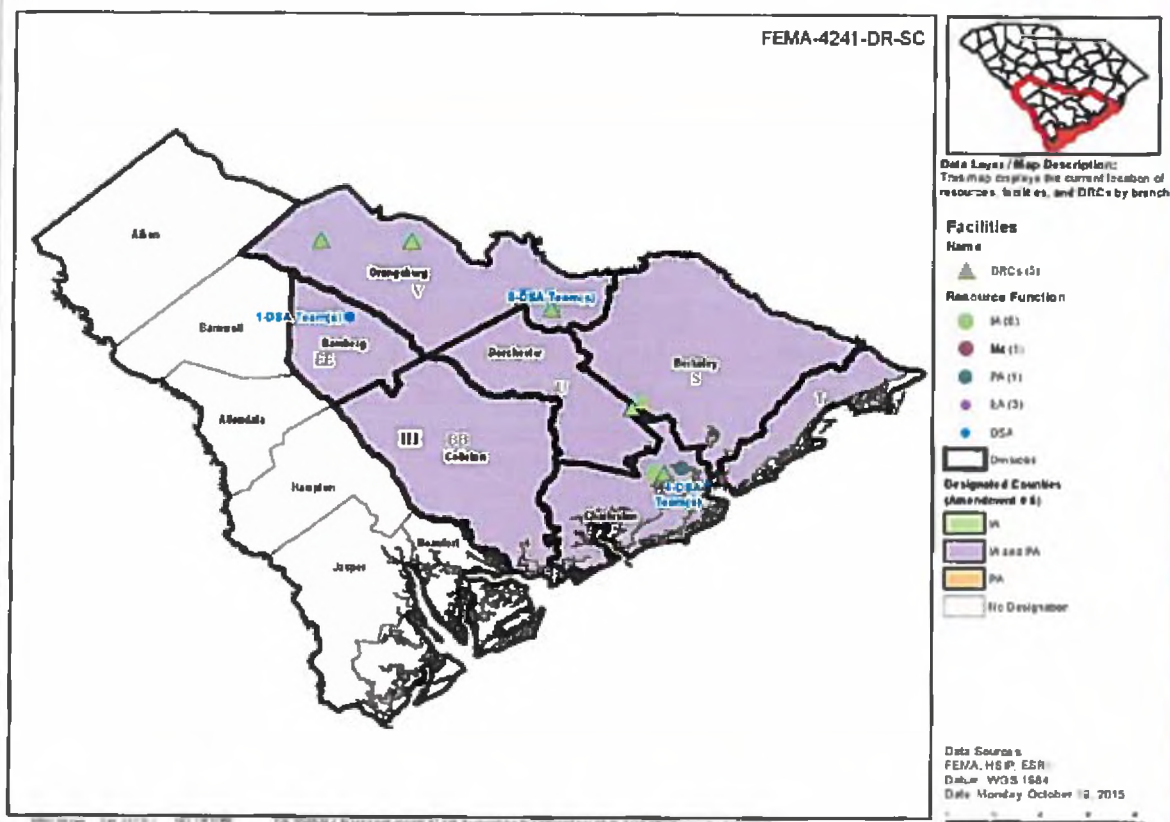

Emergent Issues: Roads and Bridges

Sumter County:

- 18 state and 1 federal roads are flooded. 14 county roads are washed out.
- 1 bridge structure is washed out. 1 bridge replacement on S-44 is needed.
- The Cains Millpond Dam (D1578), Lake View Pond Dam (D1917), and Ellerbees Mill Pond Dam (D1460) breached. There is no threat to public safety.

Lexington County :

- 46 roads are damaged. Source is South Carolina DOT and Division C Supervisor.

Richland County:

- 86 roads are damaged. Source is South Carolina DOT

Georgetown County

- 4 State, 2 washouts. Pennyroyal Rd. closed until after 11-26-15.
- All roads to Big Dam Swamp open, Pine Tree Landing closed.

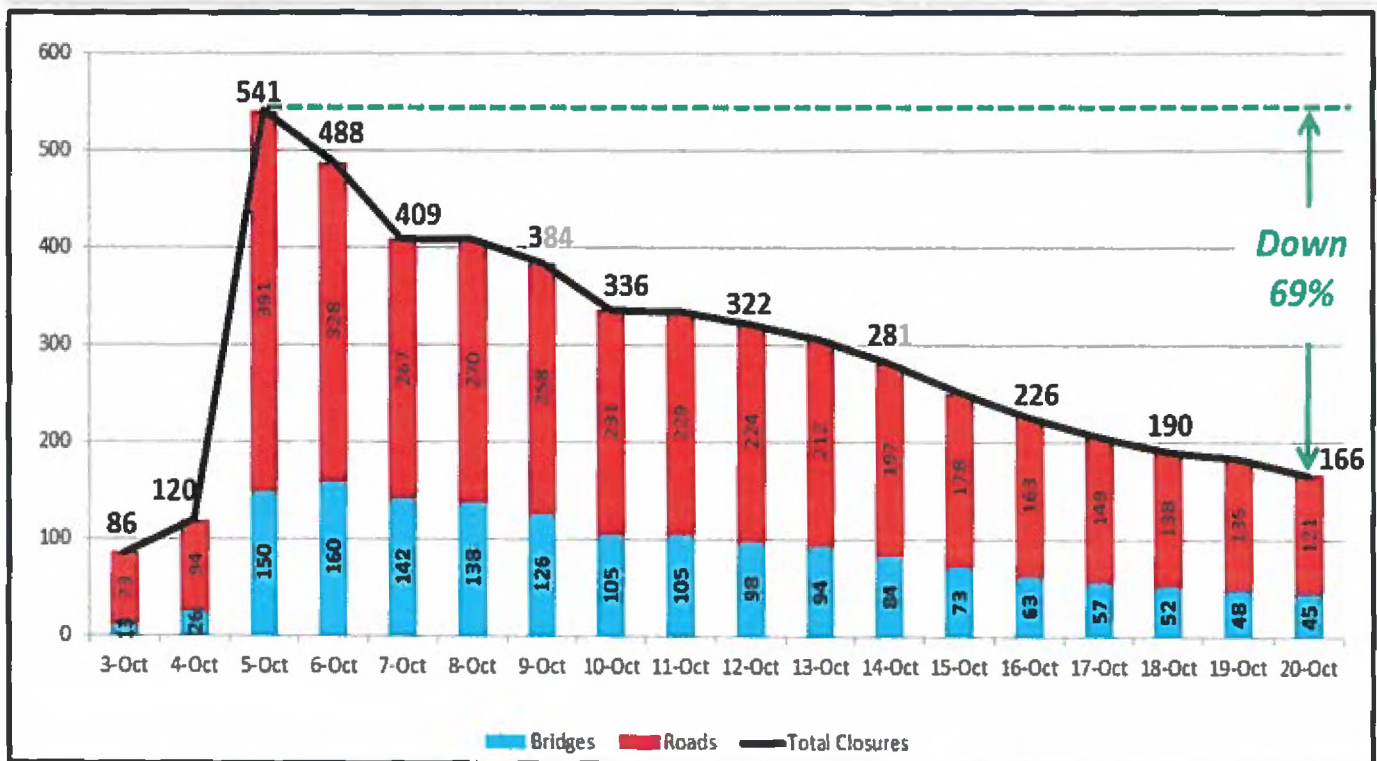

Resources Currently Deployed on Recovery Operations

- ◇ Approximately 300 SCDOT Highway Work Crews are assigned to the event. Over the past 2 days, we staggered rest periods which staffed recovery efforts at approximately 156 Crews or nearly 1100 Highway Workers addressing the closures on Monday.
- ◇ 19 Highway/Bridge Contractors have been engaged to assist with 52 different "emergency/spot repairs" in 12 counties. 18 of the firms are SC firms, 1 GA firm. 3 of the firms are DBEs.
- ◇ 6 Debris Removal Contractors have been engaged. 2 are SC firms. 36 Debris Collections Trucks & Trailers are operating.
- ◇ SCDOT Call Center is operating 6 am—7pm daily. There have been over 3.5 Million visits to the SCDOT Road Conditions webpage during this event.

Closures on the State-Maintained System



All Interstates are OPEN.

16 Primary Routes remain CLOSED statewide. Richland: US 21, US 321, SC 12, SC 48, SC 263, SC 760 & SC 769. Clarendon: US 15, US 301 & US 521 (partial). Kershaw: SC 12. Orangeburg: SC 6. Newberry: US 176. Florence: SC 51. Sumter: US 76 Business. Williamsburg: SC 512.

Majority of the current closures are on the Secondary System. Priority is placed on high volume Secondaries, routes around schools, fire departments and other critical access areas.



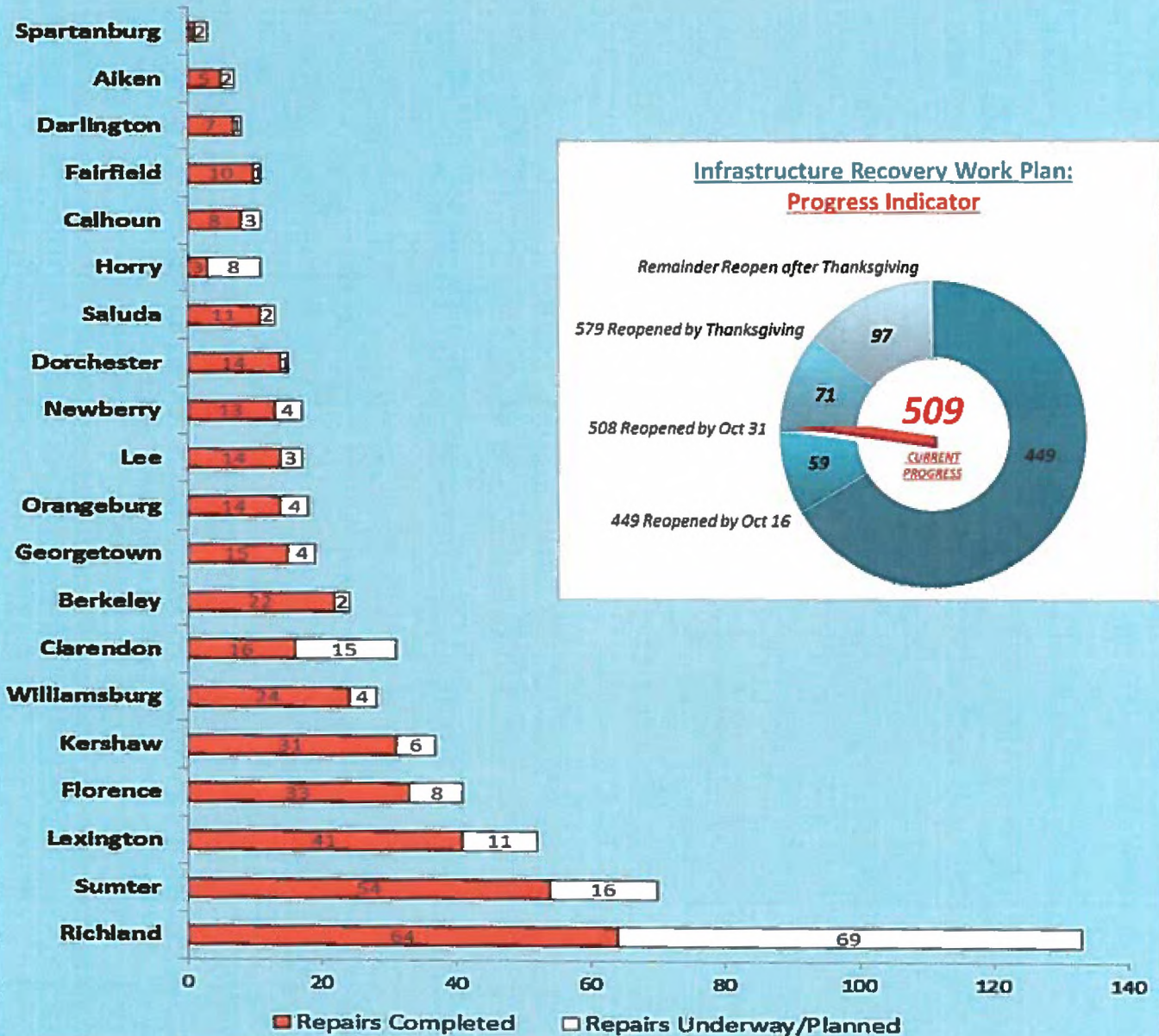

Repair Status for State-Maintained Road & Bridges



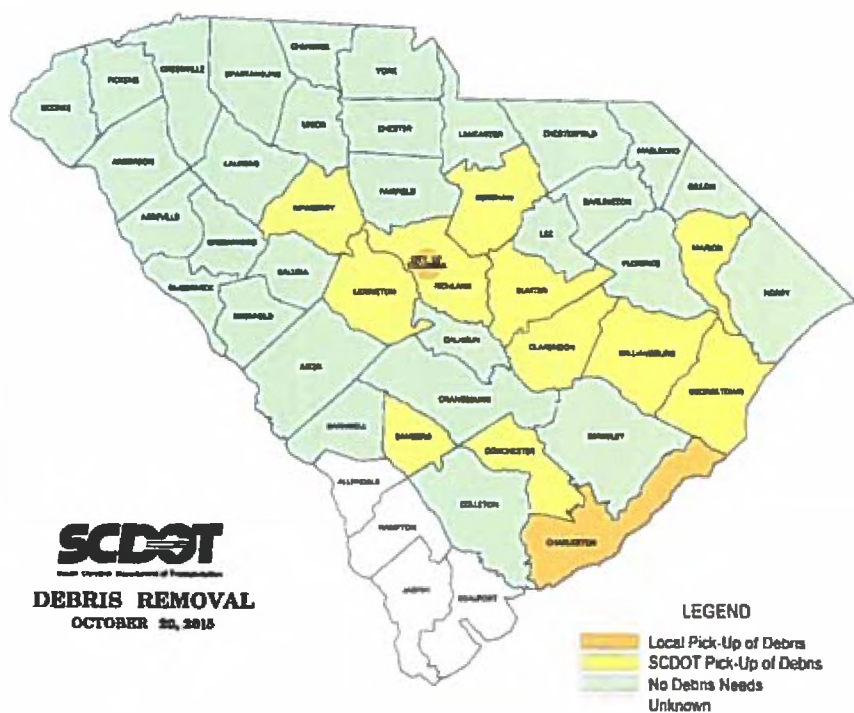

- ◊ **Transit, Airports, Ports, Passenger Rail and Short-Line Rail** are all operating **NORMALLY**.
- ◊ **Norfolk Southern:** Columbia-to-Spartanburg Line (W line) is projected to be out of service until the week of Nov 9 due to bridge repairs. Traffic is being rerouted to accommodate local service with minor delays expected.

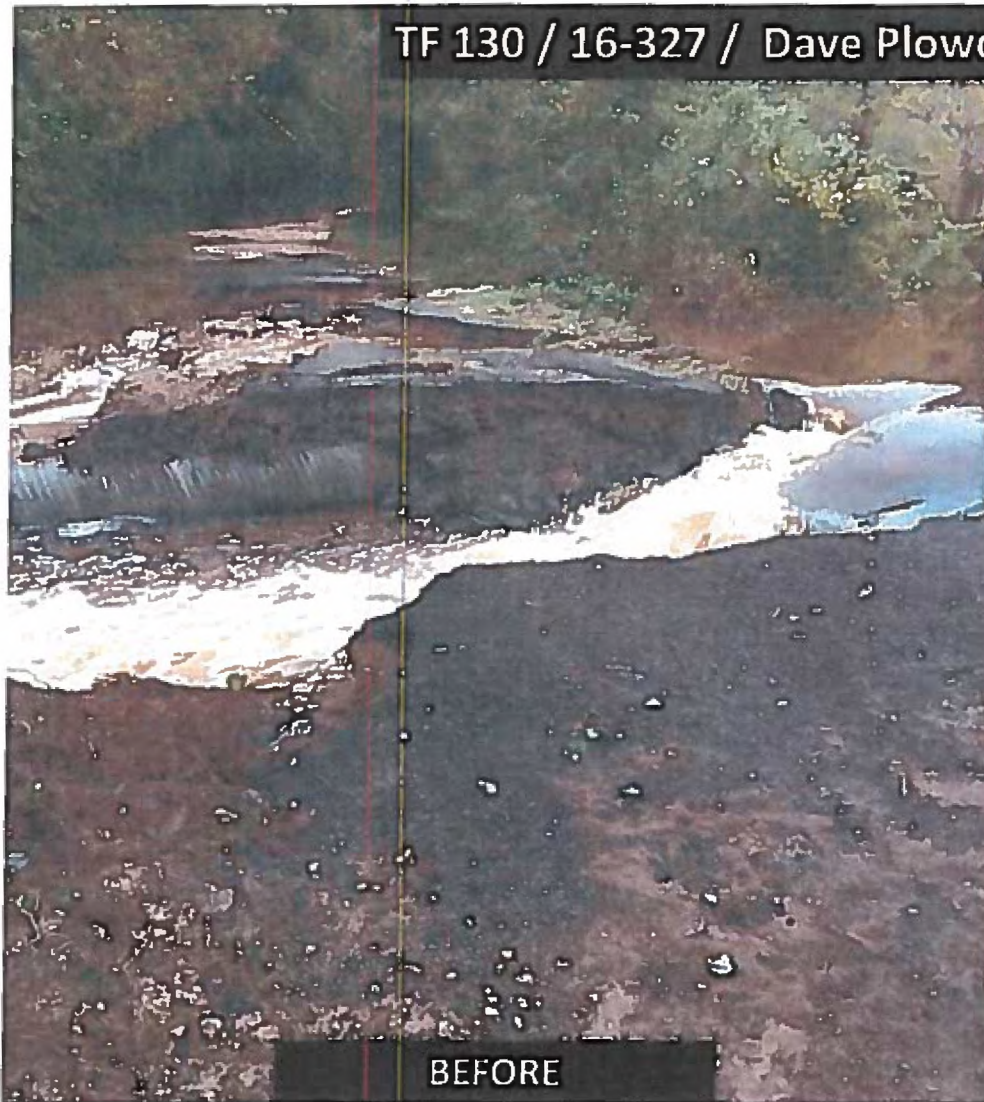

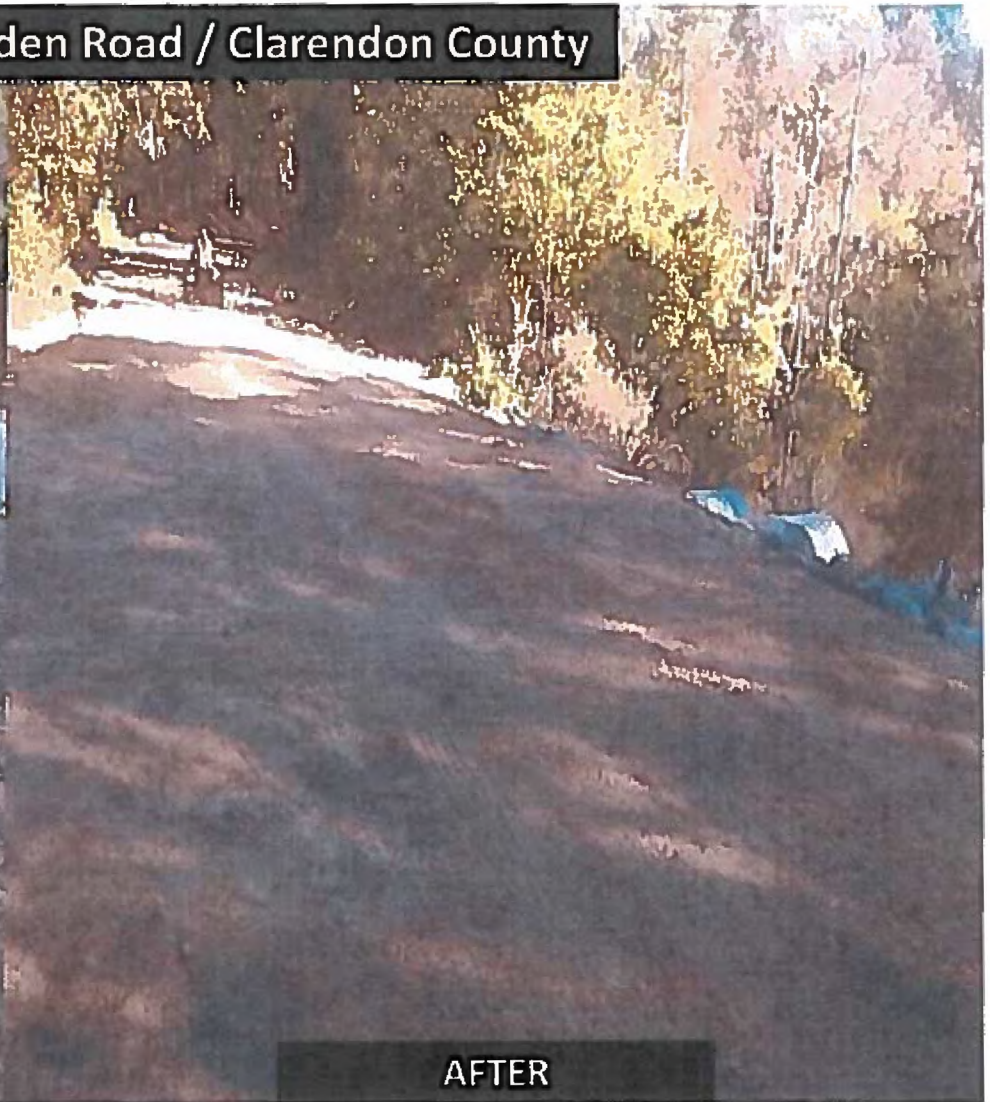

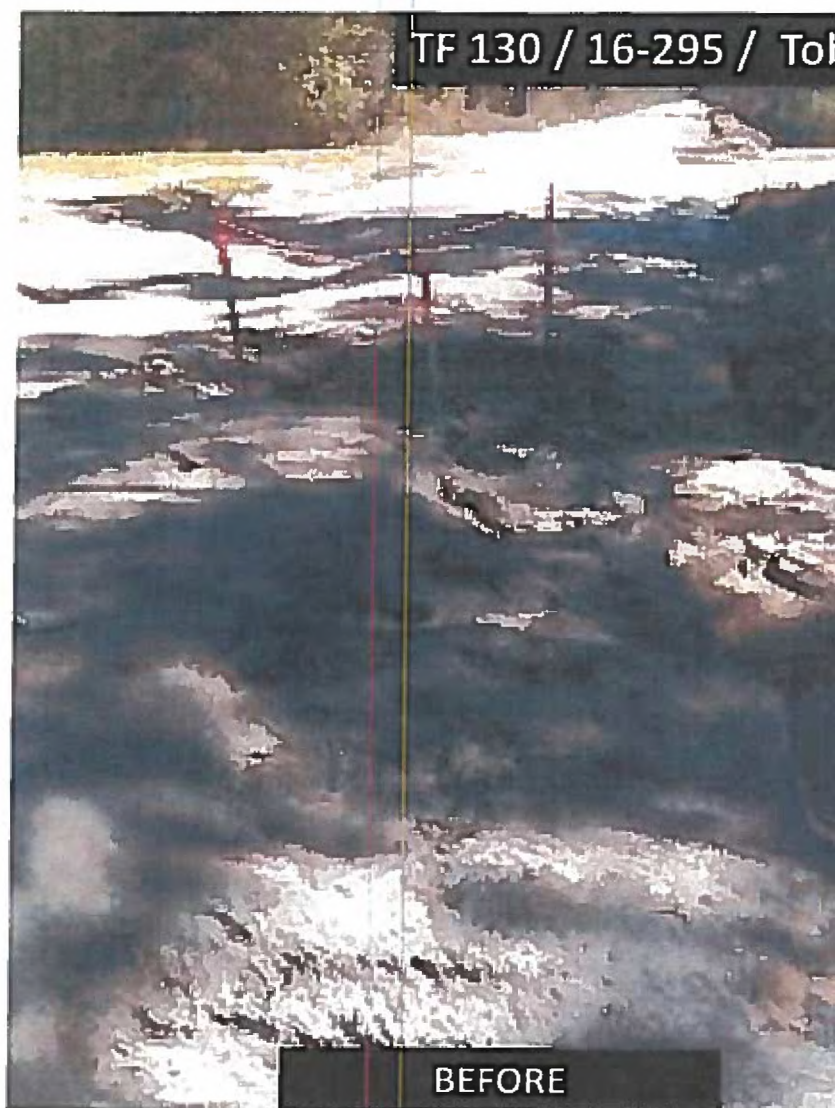
