Mr. Poore called the meeting to order and Mr. Hooper gave the invocation.

On the motion of Mr. Hooper, seconded by Mr. Bratcher, Council voted unanimously to approve the minutes of the April 4, 1978 meeting as mailed.

Council accepted as information a discussion from Mr. Bill Bond, Director of Development, South Carolina Appalachian health Council, concerning a Solid Waste Recovery System. Mr. Poore stated that before the matter is brought before Council to be discussed further, he will meet with Mr. Clinton King, Director of Anderson County Solid Waste Authority, representatives from both the South Carolina Appalachian Health Council and South Carolina Appalachian Council of Governments, Anderson County Mayors, Anderson County Aldermen, County Council, and the Planning and Development Board.

Council agreed to authorize the Tax Assessor's office to continue selling aerial photographs at an amount of \$5 each.

On the motion of Mr. Hooper, seconded by Mr. Gerrard, Council voted unanimously to continue to use Blue Cross/Blue Shield as Health Insurance for County employees.

On the motion of Mr. Wright, seconded by Mr. Gerrard, Council voted unanimously to adopt Resolution # 48 (Disposition of Surplus Property) (see attached copy). Mr. Poore stated that the surplus property will be auctioned off on May 13, 1978 at 10:00 a.m.

Mr. Poore recommended that County Council donate a used non-electric typewriter to Ms. Rose Pressley, an ex-employee of Anderson County, for her many years of service in the Clerk of Court's office. Mr. Wright stated that Council should check with the County Attorney to find out if it has the right to give away County property before rendering a decision. Council received Mr. Poore's recommendation as information until its next meeting on May 2, 1978.

On the motion of Mr. Wright, seconded by Mr. Hooper, Council voted unanimously to transfer to the Tax Assessor's office a 1974 Chevrolet and a 1974 Ford Torino from the list of surplus property scheduled to be auctioned off on May 13, 1978.

On the motion of Mr. Hooper, seconded by Mr. Wright, Council voted unanimously to adopt on second (2nd) reading Ordinance # 26 (Anderson Memorial Hospital Project).

Mr. Brantley E. Jordan, Jr. requested Council authorize a bridge be built across a creek that is hindering him from getting to other parts of his property. Mr. Poore stated that unless County Council is authorized by the Grand Jury, it cannot do work on private

property. He also suggested that Mr. Jordan get with him to meet with the Grand Jury at the beginning of May, 1978 to see what can be worked out concerning the matter.

On the motion of Mr. Hooper, seconded by Mr. Gerrard, Council voted unanimously to adjourn at 7:55 p.m.
