M I N U T E S

A CALLED MEETING OF THE ANDERSON COUNTY COUNCIL WAS HELD ON DECEMBER 29, 1986 AT 5:00 P.M. IN THE ANDERSON COUNTY COUNCIL CHAMBERS - ROOM 109. CHAIRMAN HAROLD E. BEEBE PRESIDED.

Mr. Hooper was out of town and unable to attend the meeting.

Mr. Beebe called the meeting to order and Councilman Robert Wiles gave the invocation. Everyone stood and pledged allegiance to the flag.

The agenda was amended to hear from Mr. Cox.

Mr. Cox moved that Mr. Don Rice be reappointed to the Airport Commission. Mr. Beebe seconded and vote was 4-0. (Mr. Hooper - absent)

On the motion of Mr. Rhodes, seconded by Mr. Wiles, Council voted unanimously to approve the minutes from the December 2 and December 9 meetings as mailed.

Mr. Mullinax presented second reading of Ordinance #216 to amend ordinance #142 Anderson County Road Ordinance. Mr. Cox moved that the ordinance receive second reading approval and Mr. Beebe seconded. Vote was 4-0.

Mr. Mullinax presented Resolution #361 approving an Airport grant agreement. Mr. Beebe moved that the resolution be approved and Mr. Wiles seconded. Vote was 4-0.

Mr. Mullinax presented Resoltuion #363 approving of the transfer of two cable televisions systems. (Cable Comm. Ass., Inc. and Lakeshore Cablevision Associates to Cable Synergy, Inc.) Mr. Beebe moved the adoption of the resolution and Mr. Rhodes seconded. Vote was 4-0.

Mr. Burns asked for Council to approve a Resolution (#362) designating \$10,000 to the City of Anderson for park improvements. Mr. Cox moved its adoption and Mr. Beebe seconded. Vote was 4-0.

Mr. Watson presented the financial and road maintenance reports for Council's information.

Mr. Watson asked for permission to transfer \$3,500 within the Sheriff's budget from fuel & oil (#501-125-036) for a matching grant for computer software previously approved into account #501-160-094. Mr. Beebe moved that the request be approved and Mr. Wiles seconded. Vote was 4-0.

Mr. Watson explained a request for additional travel expense for Ms. Jo Brown, Senior Citizens Director. The amount needed for the remainder of the fiscal year is \$500.00. Mr. Wiles moved to transfer \$500 from the contingency fund #443-140-065 into Senior Citizens account #709-125-035. Mr. Cox seconded and vote was 4-0.

Mr. Watson presented the following budget transfers for Mr. Beebe.

- transfer \$8,000 from Building Codes (#506-100-002 - Salaries-Part time/temp) into the Contingency Fund: #443-140-065
  - transfer \$8,000 from Airport Security into the Contingency Fund (443-140-065)
  - transfer \$11,500 from Road Maintenance - Asphalt (#601-140-057) into the contingency fund #443-140-065
- Total transferred: \$27,500
- Appropriate \$2,500 to Williford Fire Department
  - Appropriate \$5,000 to Center Rock Fire Department
  - Appropriate \$20,000 to Double Springs Fire Department
- Total appropriated: \$27,500

Mr. Beebe moved to approve the above transfers and appropriations. Mr. Cox seconded and vote was 4-0.

Mr. Jack Crowe presented Council with an ambulance repair summary as directed.

Mr. Crowe recommended the purchase of 1520' of fence at the Law Enforcement Center from Oconee Fence & Landscaping for a contract price of \$13,564.11 Mr. Cox moved that the purchase be approved and Mr. Rhodes seconded. Vote was three (3) in favor (Rhodes, Cox, Beebe) and one (1) opposed.(Wiles)

Mr. Wiles explained that the County was demolishing certain houses in the County. He said that the owner of a house on Nixon Street had no notification of the house being demolished. He then moved that this house be placed on hold until the problem is checked to see if proper procedures are being followed. Mr. Beebe seconded and vote was 4-0.

Council heard from concerned citizens. Council adjourned at 5:30 p.m.
