## Banking Status & Financial Behaviors of Adults with Disabilities Report

On April 30th, the National Disability Institute released a new report, *Banking Status and Financial Behaviors of Adults with Disabilities: Findings from the FDIC National Survey of Unbanked and Underbanked Households*. Based on data from a 2013 FDIC National Survey, the report highlights the financial choices and banking habits of adults with disabilities, including the finding that nearly one-fifth of households headed by working-age persons with disabilities were unbanked (18.4 percent) and more than one-fourth were underbanked (28.1 percent).

The overall goal of this grant opportunity is to develop innovations that can be successfully replicated by the Senior Medicare Patrol (SMP) and State Health Insurance Assistance Program (SHIP) grantees to expand and integrate program coverage to better serve traditionally hard-to-reach populations through new, efficient, and sustainable approaches for ensuring high quality and culturally competent service delivery. Applicants may select one of the following priority populations for their targeted approach or may submit an application for a different target group if they can provide rationale and data to support the need for that targeted population (Applicants that wish to target more than one of the priority populations must submit separate applications for each population):

The bulletin explains that the community spouse's minimum monthly maintenance and housing allowances are adjusted according to the changes to the federal poverty level, effective July 1 of each year.

## From Congress

### House and Senate Release Budget Conference Agreement

On April 29, the Chairmen of the House and Senate Budget Committees announced that they had reached an agreement on the FY2016 budget resolution. Under the agreement, the Federal Government would reduce domestic spending by nearly \$500 billion over the next ten years. The agreement also includes a repeal of the Affordable Care Act. The House subsequently passed the agreement on a vote of 226-197, while the Senate is expected to address the measure in the near future. The budget agreement sets a framework for the overall Congressional budgeting process and establishes the top-line expenditures in each category and is only subject to a majority vote in each chamber. However, actual FY2016 spending levels will be determined by the Appropriations bills, which are subject to a 60-vote threshold in the Senate as well as a Presidential veto.

## Mathematica Policy Research

### **Webinar & Event: Improving Employment Opportunities for Youth with Disabilities**

Youth with disabilities face distinct challenges in transitioning to work and economic self-sufficiency. To help them overcome these challenges, the Social Security Administration sponsored the Youth Transition Demonstration (YTD) from 2003 to 2012. Interventions to help youth with disabilities navigate the transition to work, including employment and education counseling, job placement services, and financial planning, were developed and tested. The demonstration also included financial incentives to encourage employment among young people who were receiving disability benefits.

Mathematica evaluated the implementation and impacts of six of the demonstration projects. In an event and webinar on

speakers will discuss: three-year follow-up data on the six YTD projects and their impacts on youth employment, earnings, and other outcomes; the Broadened Horizons, Brighter Futures project in Miami-Dade County, which improved more outcomes for youth than any of the other five evaluated projects did; and an analysis of the effect of early work experience on later paid employment for youth ages 18 to 20 who have disabilities.

### **HCBS Quality Measurement Workgroup Meeting & Activities**

The HCBS Quality Measurement workgroup met for the second time this week for a two-day in person meeting in Washington, DC. Camille Dobson, NASUAD Deputy Executive Director, is representing states' interests on the workgroup, along with Patti Killingsworth from Tennessee's Medicaid agency. Over the two days, the workgroup members developed a draft definition of HCBS and began laying out domains of measurement for the framework that the workgroup is charged with developing. The NQF staff will be working over the spring and summer on finalizing that work as well as conducting an environmental scan of HCBS measures that address the domains of measurement. The workgroup will react to their findings at the next teleconference in August, with the workgroup's first report being published this fall.

## Home Care Worker Turnover above 60% in 2014

According to the 2015 Private Duty Benchmarking Study, over 60 percent of caregivers working for private duty home care companies quit or were fired from their jobs in 2014. The median turnover rate of 61.6 percent is the highest recorded by the Study since it began in 2010. Median turnover rates were highest in the Great Lakes and Central regions of the United States. More than 700 home care companies participated in the 2015 Benchmarking Study. The survey also provides data on caregiver wages and benefits and agency profits.
