Governors' Salaries 2016

The Council of State Governments has been collecting data on governors' salaries for *The Book of the States* since 1937. The average governor's salary grew more slowly during and after the Great Recession, with many states instituting a ban on cost-of-living adjustments; however, as the economic and fiscal health of states has improved, the annual increases normally seen in executive branch pay are returning to a more historically customary level in some states, particularly those that provide cost of living adjustments annually.

State Minimum Wage Update

On July 1, 2016, the minimum wage increased in Oregon, Maryland and Washington, D.C. The total number of states with a minimum wage higher than the federal rate of \$7.25/hour is 29, ranging from \$7.50 in New Mexico and Maine to a high of \$10 in Massachusetts and California and \$11.50 in the District of Columbia.
