





In Ethiopia , the Chief Commissioner of Ethiopia's Human Rights' Council , Dr. Addisu Gebreigzabghier , called for respect and protection for human rights for all through good governance and sustainable development . Very appropriately , in Ethiopia the UN Human Rights Day is celebrated the day after the country's own Nations , Nationalities and Peoples' Day . This was created a decade ago by the House of Federation to underline the ties between Ethiopia's nations , nationalities and peoples and to strengthen the country's unity in diversity . It exactly affirms respect for the fundamental rights of individuals and of the nations , nationalities and peoples of the country as well as the development of the country ; Heilemariam Dessalegn , Prime Minister , FDRE noted the Constitution had provided for a flourishing democratic nationalism and strengthened the fight against poverty designed to fulfill the needs of the people and ensure equitable economic benefits for all ; ... This has enabled the nations , nationalities and people of the country to freely practice their own cultures and promote their own heritage through the development of their own written literature and arts and in other areas as well as provide the basis for implementation of the four universal freedoms - freedom from fear , from want , of speech and of thought , conscience and religion - celebrated under the heading **Human Rights Day celebrated in Ethiopia on December 10 ;**

In harmony with Ethiopia's selected to host the next annual meeting of the Intergovernmental Committee for the Safeguarding of the Intangible Cultural Heritage , to take place from 28 November to 2 December 2016 in Addis Ababa , Ethiopia ; to be chaired by Yonas Desta , Director General of the Authority for Research and Conservation of Culture Heritage (ARCCH) . The Committee decides on measures to safeguard oral traditions and expressions , performing arts , social practices , rituals , festive events , knowledge and practices concerning nature and the universe or the knowledge and skills to produce traditional crafts , which constitute intangible heritage , under the heading **Ethiopia to host 11th session of the Committee for the Safeguarding of the Intangible Cultural Heritage (Dec 22, 2015) ;**

In harmony with the Ethiopian Media Council formally established in the UN Economic Commission for Africa (ECA) on Tuesday, January 12th, 2016. The Council is expected to create awareness about freedom of expression among the public and act as a mediator and arbitrator in cases where disputes and grievances with relation to media arise. Getachew Reda, Minister, Head of the Government Communication Affairs Office in his key note speech noted the Government of Ethiopia commitment to constructively engage in the Council's organized efforts of forging national consensus and enhancing the process of democratization in the country. Ahunna Eziakonwa-Onochie, UN Resident Coordinator pointed out that the media is a powerfully inquisitive tool that shines light on triumphs as well as failures "and even more importantly provokes deep reflection and dialogue," under the heading **The establishment of an Ethiopian Media Council**;

In harmony with the Federal Democratic Republic of Ethiopia and the International Criminal Police Organization - INTERPOL signed agreement towards establishing a Special Representative Office in Addis Ababa, 26 January 2016. Taking note of the fact that the signing of the agreement was a "historic episode," Jurgen Stock, Secretary General, INTERPOL noted that a strong alliance was required in the fight against challenges such as organized crime; "the signing of the agreement offered tremendous opportunity in fulfilling our mission," under the heading **Ethiopia and INTERPOL sign an agreement towards establishing a Special Representative Office in Addis Ababa. In harmony with the Government announced Ethiopia's bid for a non-permanent seat on the United Nations Security Council for 2017-18 . It was announcement that underlined Ethiopia's renewed commitment to middle-level diplomacy and its ambition to actively develop its regional and global policy agenda . Ethiopia has , therefore , shown its interest in being elected to the Security Council again . It is , of course , a founding member of the United Nations , one of the only two African founding members of the United Nations Organization set up following the end of the Second World War , the other being Liberia . It has been a non-permanent member of the Security Council on two previous occasions , in 1967/1968 and 1989/1990 .

From the outset , it has demonstrated real commitment to the United Nations , as it did to its predecessor , the **League of Nations** , and to the principles of collective security anchored in the UN Charter under the heading **Ethiopia's Candidature for Non-Permanent Membership of the Security Council - A Week In The Horn of Africa 29 January 2016 ;**

In harmony with the hosting of the International Coffee Organization's (ICO) 4th World Coffee Conference on March 6th- 8th, 2016 and the 116th International Coffee Council meeting on March 9th- 11th, 2016 in Addis Ababa . The conference is the first of its kind in the African continent and Ethiopia is the first African Nation to host the main event under the theme ' Nurturing Coffee Culture and Diversity ' ; under the heading **Ethiopia set to host the 4th World Coffee Conference (Feb 22, 2016) ;**

In harmony with the UN Human Rights Council special gathering as part of its 31st session , providing an opportunity for high-level delegations to mark the 50th anniversary of the **International Covenant on Civil and Political Rights** and the **International Covenant on Economic , Social and Cultural Rights** . Respectively promoting respect a top UN official stated the landmark covenants have helped extend rights to people crushed by tyranny and discrimination for generations .

" Humanity's collective experience of genocide , of devastating warfare ,

of colonial oppression and financial devastation had driven home the fact that respect for the human rights of all individuals ensures that nations and peoples can live in peace , with development that is sustainable and long-lasting ,” stated Zeid Ra’ad Al Hussein , UN High Commissioner for Human Rights . “ Human rights build peace within and among States ,” he continued . “ Human rights ensure opportunities and the right to development for all . What connects us is much stronger than what divides us ,” under the heading **Human rights treaties are ‘bedrock of sound governance ,’ says top UN official marking 50th anniversary 1 March 2016 ;**

In harmony with the two-day consultative forum aimed at enhancing the role of the Broadcast Media in Ethiopia held (March 7th-8th, 2016) at Hilton Hotels in Addis Ababa , under the theme : “ Broadcast media , rule of law and national consensus .” Co-organized by the Ethiopian Broadcast Authority and Government Communication Affairs Office , the forum brought together policy makers , representatives of government and private broadcasters , media experts , journalists and other stakeholders . Ato Demeke Mekonnen , Deputy Prime Minister stated media should continue their efforts in building democracy , ensuring good governance and forging economic development , which he said are the primary concerns of the peoples of Ethiopia . 




