

To: The Subcommittee on Regulatory Affairs and Federal Management / Homeland Security and Government Affairs Committee

October 26, 2016

In 2010 the lead investigator and attorney selected identifiers prior to creating a ruse of an investigation. Each identifier selected from, and exactly identical to, SS Nazi identifiers used to precede the contrived Nazi fabrications and falsifications to fit each identifier. The Nazi torture tactics as well as the propaganda tactics used on the general public to gain participation in committing crimes and/or looking the other way have been crafted during these past 6 years by the lead investigator and attorney from Columbia, SC to include thousands now, individuals and many businesses and public offices as well, all victims. The crimes in this case of Nazi torture and propaganda to dehumanize, de-spiritualize, and create distrust in the general public of the United States government, will be the easiest to prove, having 6 years of documentations all fabricated in various manners and piled one upon the other; but also, the most heinous imaginable and unprecedented in the US, and will expose the widespread and rapidly destructive ability of those employing Nazi tactics in this manner which seems to be undetected. The focus, as I hope is being monitored by those in intelligence areas regarding the current advancement of the Nazi agenda in the US, is not like its counterparts bombing buildings; but, in the silent arenas such as I have described, to utilize only one person at the core, me in this case, in order to adversely manipulate the will of many.

All my efforts to expose this have been blocked; so, I find this agency to be the place where there are those whose profession it is to investigate problems of this nature and whose understanding of all these issues is acute and will not be deterred in the same manner used by the attorney and lead investigator with those before you, that you will easily recognize all constructs to deter you are simply the evidence to which I am alerting you. I also trust that as the US prosecutor during the Nuremberg trials noted, the intent of the articles created was not only for the present moment and crimes; but also for the future, in anticipation of the continued threat of Nazism and that no matter how unreasonable the crimes against humanity and peace appear when reported, no matter how large the scale - of collusion, misfeasance, malfeasance, corruption, aspects of lawlessness, improper practices, and activities to the detriment of the public necessary to determine changes needed, to quote from the Committee on Homeland Security and Government Affairs - it would be addressed, exposed, and measures put in place to prevent those crimes and never lose sight of the threat of Nazism.

Of concern during the Nuremberg trials was not only the difficulties in assessing the psychological aspects of Nazi propaganda and the success of denazification strategies, but also the lack of information from so many victims over the course of many years prior to, during, and after the 1940's. Everyone - except those responsible for the 2010 design of the Nazi crimes referenced here - is a victim, and understanding the long term proliferation of Nazism and its

propaganda tactics necessitates each victim being included in the assessment of the threat, completely unhindered from fear, the fear that I witness every day, the fear that the tenets of Nazi propaganda tactics intentionally create.

11/7/16 More than the fear I see in those who become aware of the severity of the crimes, as is the goal of Nazi propaganda regarding the general public, is the learned enjoyment by others of those heinous crimes-to name a few: poisoning with furfuryl alcohol and other toxic substances such as heavy doses of pesticides long term in my home and car on a daily basis, home, car, clothes, and other items in my home vandalized using exact Nazi tactics as to the types of vandalism, a viscous chemical polymer that cannot be removed covers my body and has been inhaled and ingested, banned from businesses I frequent based on fabrications crafted following Nazi tactics and the same tactics are being employed toward "homelessness" and "pauperization", computer (personal and at Hilton Head Library) hacked and communications-thousands-to report these crimes are blocked, my job taken from me, raped, drugged on various occasions, speaking out about these crimes leads to fabrications toward my mental health, forcing me into an EMS van, taking me to a hospital where upon speaking of the corruption, leave with another fabrication of a mental health problem, and/or imprisoning me. These are only a small number of examples. Lastly, for now, regarding the progression of these Nazi torture tactics during these past 6 years, and the resulting crimes against peace and humanity, and due to the broad scope of inclusion by victimization and manipulation of the general public, the culmination seems to very likely to be an act of war against the United States of America.

The level of those participating is in the thousands, thousands of victims. Everything and every documentation has been, in these ways, fabricated or falsified, as well as planted and tampered evidence. To deny these most heinous crimes because of the nature of the crimes allows them to continue. Most assuredly though, there are others in places of authority who are not looking the other way and are watching this all very closely, those who are advancing the Nazi agenda, those to whom World War 2 was simply a battle in the continuing War of Nazism.

I am not attempting to cover up the smells of long term poisoning, drugging, exposure to a multitude of harmful substances intentionally placed in my home, car nor any other symptom of the damages or my day to day adaptations to the crimes of psychological and physical torture being committed against me. At the same time, it is saddening that even though many in the community of Hilton Head Island, Buckhead/Atlanta and Columbia, SC are aware of all of this, they chose to allow the fabrication and falsification of evidence against my mental health to aid in covering up these heinous crimes, and worse yet, many find joy and camaraderie observing torture, corruption, and my "Death by 1000 Cuts", more accurately "Murder by 1000 Cuts".

One of the symptoms of long term furfuryl alcohol poisoning is hypersensitivity, while the other physical damages are much more severe and not so obvious. The hypersensitivity noticeable in my face (especially after getting out of my car where several times a day pesticides and other chemicals are sprayed on the windshield and elsewhere), is the planned cover up to dupe the public once the long-term effects began to show. Members of the community have been coached, as is part of the lead investigator and attorney's model of torture, to speak to me of rosacea and hypersensitivity to foods. I believe many are used unknowingly in this way, reminding me of the intentionality of the poisoning, the continuation of the poisoning and its damage, and the cover up as well as telling many people in the community I am being exposed to something that is innocuous and manipulating them to believe and accept that even that is justified.

The attorney and lead investigator are encouraging and documenting comments from members of the public regarding the smells of the poisons and drugs which are no longer flushed out as the rate of decaying cells out paces the growth of new cells and the higher doses and increased frequency of exposure and reactions with the viscous chemical polymer that I have ingested, inhaled, and covers my entire body in order to fabricate evidence against my mental health as well as supporting fabrications to have me banned from places I visit and my residence at Hilton Head Beach and Tennis as well.

Other initial cover ups set in place in 2010 included manipulating situations to pile on fabrications, intentionally about me being child like or adverse to aging, so that symptoms of these heinous acts would go undetected and ridiculed denying many in the community the opportunity to know about the crimes being committed in this way, if I spoke out about them.

My death from these poisons, substances, and drugs, is certain. The lead investigator and attorney from Columbia, SC are not only treasonous; but, sociopathic murderers and intended to shift responsibility to the public and nurture sociopathy in each person participating or allowing it to happen. Many already understand these things and are trapped by the corruption to stop it or expose it, which is tyranny.

Throughout my day, I visit these places: Whole Foods, the park behind Whole Foods, CVS, Kroger, the park behind Kroger, St. Francis' Thrift Shop, the Hilton Head Library, the Northridge Theatre, my residence, Hilton Head Beach and Tennis. I have been banned by Barnes and Noble. Observe before, during, and after my visits; have individuals employed at these places, insert yourself into the telephone loop, observe the illegal surveillance of me in my home...but now, I veer away from my job, which is simply to be a place holder, a good steward, a good citizen, to not be silenced and to serve my country in this way and plant seeds of awareness, experience, and expertise in furfuryl alcohol poisoning, linguistics, SS Nazi propaganda and torture, and corruption will know I am the only person with all the information, the one who is completely isolated and thousands of communications blocked for a very long time. However, I will provide you who wish to stop and expose this, a list of where there is a trail of evidence; each and every documentation holds the truth of these crimes as well as the easy to separate

layers of themed fabrications. (A few individuals are used by keeping them ignorant of the crimes, such as Deva Joy Gauss.)

The only hold the lead investigator has is the hope that no one will figure out the simplicity of it all, that your greatest strength is your worst fear, a false fear created intentionally by the lead investigator and attorney. *You see, instead of shame* or fear of legal reprisal, or your misdirected anger toward me, or denial of the truth of the lead investigator and attorney being sociopaths who chose me, someone vulnerable, in order to fabricate and falsify ways to create feelings of disgust simply to manipulate you to feel justified to participate or allow SS Nazi torture, murder, and destruction of our community and nation - *it's the opposite*.

Hilton Head can lead the country and the world would know. Imagine how, when unveiled, Hilton Head will not only show other Americans how to understand and identify SS Nazi propaganda tactics of the 21<sup>st</sup> century; but, the entire world can learn how to recognize it, name it for what it is - SS Nazism - and prevent it. If you laugh at this, remember the lead investigator and attorney are laughing at you.

Everyday these past 6 years, this attorney and lead investigator have laughed at you all, mocked our constitution, scoffed at our legal and judicial systems, used our country as their playground to fulfill their sociopathic needs and destruction of our country, created distrust in our local, state, and federal government so as to squash our American spirit from within, all the while substituting a temporary sense of patriotism to fool and rally members of the community to commit acts of torture and "Murder by 1000 Cuts" while strengthening each person's loyalty to all the tenets of Nazism.

Instead, why not take up arms, the arms of knowledge and put aside the hold that falsely riles your emotions in this stage of SS Nazism. Read the words, the thoughts, the plans, the ideology, the religion of Nazism, the resolution of 100 years of documentation by Nazi's and Nazi supporters. Yes, Hitler described in detail his plan and his creation of a religion that used aspects from other religions such as Christianity, but with him at the center, instead of Christ.

Forty internet contacts equate to 250 million people being connected. Given that, there are many others all over the world who are cheering the success of this SS Nazi campaign in their war of Nazism and terrorism and, if not already, will implement this strategy in other communities in the United States.

I understand the inclination to emotionally deny even these possibilities. At the same time, I, just like you, know many wars have been fought because in these very possible moments of great importance; denial over took the ability to pause, to learn, to stop what is within our power as individuals. I am not the enemy. The enemy is hate, corruption, and ignorance, the very predictable tools wielded by this investigator and attorney to manipulate you.

Never deny the importance of a moment. Never deny your ability to stop corruption, Nazism, hate, and war. The only thing that separates them is a little time; but it is time that also connects them, assures their relationship is an absolute truth.

The power of absolute truths of the United States of America, its love filled ideals and Constitution, is our map of peace for ourselves, each other, the world, and with time and devotion will transform everything not of love into love.
