#### CFPB Unveils Sweeping Payday Loan Protections

The U.S. government's consumer finance watchdog on Thursday released a long-awaited proposal that would see payday, auto title and other lenders be forced to carry out strict borrower reviews as part of an effort to reform the industry at the national level.

#### Calif. Regulators Float Methane Rule For Oil, Gas Sector

California air regulators have proposed regulations that would clamp down on methane emissions from upstream oil and gas facilities, part of the state's aim to slash emissions of the short-lived but potent greenhouse gas by 40 to 45 percent by 2025.

#### US Dings UAE On Foreign Investment Hurdles

A U.S. Trade Representative official has voiced concerns about the United Arab Emirates' lingering barriers to foreign investment, saying Wednesday at the country's third World Trade Organization trade policy review in Geneva, Switzerland, that the UAE should examine the effects of its market restrictions.

#### Calif. Assembly Rejects State Bar Dues Legislation

The California State Assembly on Tuesday strongly rejected passage of a bill reauthorizing membership dues for the California Bar, as lawmakers from both sides of the aisle said the legislation doesn't go far enough to reform the besieged arm of the state judicial branch.

#### Wyo. Defends Ban On 'Open Land' Data-Gathering

Wyoming officials on Tuesday asked a federal judge to toss a lawsuit filed by conservation groups that alleges the state Legislature passed trespassing laws that improperly prevent private citizens from entering "open land" to collect information about agricultural pollution.

#### Fattah Associate's Girlfriend Pressed Over Alleged Bribes

The girlfriend of a former Stradley Ronon Stevens & Young LLP government affairs specialist was pressed Wednesday on whether she'd known about alleged bribes he made to Rep. Chaka Fattah, D-Pa., that prosecutors say resulted in her landing a job in the indicted congressman's West Philadelphia district office.

## SEC's In-House Courts Safe For Now After 2nd Circ. Win

The U.S. Securities and Exchange Commission can rest easy for a while after the Second Circuit found private equity magnate Lynn Tilton must face the agency's in-house court before challenging the tribunal's constitutionality, with experts saying it could be a long time before the U.S. Supreme Court ever gets to the merits of the issue.

## BANKING & SECURITIES

### SEC Beats Tilton's 2nd Circ. Challenge To In-House Court

A divided Second Circuit panel on Wednesday ruled private equity magnate Lynn Tilton can't challenge the constitutionality of the U.S. Securities and Exchange Commission's administrative court until the agency has wrapped up a \$200 million fraud case against her and her Patriarch Partners firms.

### EU Watchdog Questions Capital Test For Market Exemptions

Using a capital-based test to decide if a company trading commodity derivatives should be exempt from stringent financial market regulation has "significant drawbacks," the European Securities and Markets Authority has said in response to calls to use the standard from the European Commission.

### ECB Rebuts Calls For More Leniency In Bank Rules

European regulators should not weaken banking rules to appease calls from the industry to go easier on smaller firms, a member of the European Central Bank's executive board said in a speech Wednesday.

### FDIC Expects Bank Failures To Continue Declining

The Federal Deposit Insurance Corporation expects that the annual number of bank failures will continue declining, after the annual total went down to single digits in 2015 from a triple-digit high during the recession, Chairman Martin J. Gruenberg said at a press conference Wednesday.

### Treasury Further Restricts North Korea's Access To US Banks

The U.S. Department of the Treasury on Wednesday proposed to further restrict North Korea's access to the U.S. financial system and designated the reclusive country as being of "primary money laundering concern" under the Patriot Act.

### Louisiana Bans Common Abortion Procedure

The most common method of second-trimester abortion will soon be outlawed in Louisiana, after Democratic Gov. John Bel Edwards enacted a ban against dilation and evacuation abortions, nonprofit advocacy group Center for Reproductive Rights said Wednesday.

### 3rd Circ. Revives Challenge To Pittsburgh Abortion Buffers

The Third Circuit on Wednesday revived an anti-abortion group's lawsuit challenging the city of Pittsburgh's ordinance imposing 15-foot buffer zones outside the entrances to hospitals and health care facilities, finding that the city failed to provide evidence that the zones were necessary.

### Pa. Readies 1st Interim Regulation For Medical Pot

The Pennsylvania Department of Health's chief said Wednesday that the state's first temporary regulation for a newly legalized medical marijuana program will focus on growers and producers, as part of an expected 18- to 24-month program implementation.

### Shippers Sue Coast Guard Over Great Lakes Pilot Rates

Shipping companies and trade groups are accusing the U.S. Coast Guard of botching the rates they must pay Great Lakes boat pilots for the 2016 season, saying the cargo firms are being overcharged, according to a lawsuit filed Tuesday in Washington, D.C., federal court.

### EEOC Ups Penalties For Title VII Notice Posting Violations

The U.S. Equal Employment Opportunity Commission on Wednesday increased the maximum penalty for employers that violate notice posting provisions of Title VII and other statutes from \$210 to \$525 per violation.

### Skadden Gets \$660K Fees After Win In Calif. Judicial Pay Row

A California judge on Wednesday awarded Skadden Arps Slate Meagher & Flom LLP \$659,759 in attorneys' fees for winning a suit alleging California's chief fiscal officer had illegally withheld automatic raises from 3,000 active and retired state judges, roughly half of what Skadden argued its work was worth.

### NJ Agency Must Face Suit Over Worker Classification Laws

A New Jersey federal judge on Tuesday refused to toss a trucking company's lawsuit contending that state statutes classifying its drivers as employees, rather than independent contractors, violate federal law, rejecting the state labor commissioner's arguments that a related administrative dispute precludes the litigation.

### **FCC Can't Impose ISP Privacy Rules, Small Providers Say**

The Federal Communications Commission does not have the authority to slap internet service providers with privacy rules, a trade group of small and medium-sized cable operators has told the FCC, saying the proposed rules would also be deeply burdensome to the hundreds of small providers it represents.

### **Ruling Could Make Chicago Mayor's Private Emails Public**

An Illinois state court judge ruled Tuesday that Chicago Mayor Rahm Emanuel cannot assert a blanket privacy exemption to the Illinois Freedom of Information Act in order to withhold emails and texts stored on his personal devices, potentially leaving the communications open to being read by the public.

### **New Cars Being Sold With Faulty Takata Parts, Dems Say**

Senate Democrats on Wednesday said four major automakers, including FCA US LLC and Volkswagen AG, have confirmed they are continuing or plan to sell new cars equipped with possibly defective Takata Corp. air bag inflators, despite a mandated recall of the parts by 2018.

### **SBA Makes Major Small-Biz Contracting Tweaks**

The U.S. Small Business Administration finalized a rule Tuesday with a host of tweaks to federal small-business contracting regulations, including clarifying the agency's "nonmanufacturer" and business affiliation rules and easing subcontracting limits and requirements for how joint ventures can qualify as small businesses.

### **No End In Sight For Ill. Budget Crisis**

After the Illinois General Assembly reached the end of the spring legislative session without a budget for the second year in a row, there's little reason to believe that the stalemate will end before the beginning of the next fiscal year, experts say.

### **CFTC Lets Shanghai Exchange Off Hook For Not Registering**

The U.S. Commodity Futures Trading Commission's clearinghouse oversight arm said Tuesday it will not recommend action against the Shanghai Clearing House for not registering with the agency, on the condition the Chinese exchange applies for a permanent exemption from Commodity Exchange Act requirements within six months.

### **China, US Slated To Roll Out Formal Ivory Trade Ban**

The ivory trade will feature as a hot topic of discussion in Beijing next week as the United States and China meet to discuss how much progress they've made on implementing a nearly complete ban on both legal and illegal trading, Catherine Novelli, U.S. undersecretary of state for economic growth, energy

### **OECD Seeks Input On Treaty Changes To Fight Tax Evasion**

The Organisation for Economic Cooperation and Development announced Tuesday that it is soliciting public comments on the creation of a multilateral instrument to modify bilateral tax treaties in connection with its efforts to combat tax base erosion and profit shifting.

### **Illinois Senate Unanimous In Vote Against Tampon Tax**

Illinois lawmakers decided to abolish the so-called tampon tax on feminine hygiene products after the state's senate unanimously passed the bill on Tuesday.

### **Wal-Mart's Tax Suit Shouldn't Have Proceeded, 1st Circ. Told**

The government of Puerto Rico blasted a federal court for preventing it from collecting an alternative corporate income tax from a Wal-Mart subsidiary, telling the First Circuit on Tuesday that the court improperly assumed jurisdiction over the retailer's suit challenging the tax.

## IMMIGRATION

### **Conservative Groups Seek Rehearing In Ariz. License Suit**

A handful of conservative groups urged the Ninth Circuit on Tuesday to rehear a ruling permanently blocking Arizona from refusing to issue driver's licenses to so-called Dreamers on the grounds that the state had encroached the federal government's exclusive power to classify immigrants, saying only Congress, not agency policy, preempts state laws.

### **IHS Seeks Tribes' Input On Health Program Expansion**

The Indian Health Service said Wednesday it will reach out to Native American tribes for suggestions on the potential expansion of a community health program in Alaska to federally and tribally run health facilities nationwide.

### **Public Needs More Insight On FCC Proposals, O'Rielly Says**

Republican Federal Communications Commissioner Michael O'Rielly increased his calls Tuesday to reform the agency's proposal process, urging the FCC to change how it handles more-minor proposals and saying the public should have more and earlier insight on changes before the agency acts on them.

### **FCC Names Auction Transition Head, Shakes Up GC Staff**

The Federal Communications Commission's deputy chair for the Telecommunications Bureau will take over the post-incentive auction transition as a deputy chair for the auction's task force, the agency announced Wednesday, one of several staff moves at the commission.

### **Media Writers Urge FCC To Protect Ads In Set-Top Box Plan**

A union representing writers for TV, radio and film has told Federal

Communications Commission officials that its plan to unlock the TV set-top box would help content creators but that benefit could be jeopardized if the commission fails to bar third-party devices from altering or replacing embedded advertising.

### **Democrats And Republicans Unite To Challenge TCPA**

In a recent Law360 Expert Analysis article, we predicted that the Federal Communications Commission's restrictions on the communication of important information to cellphone users would be challenged for burdening far more speech than is necessary to serve any significant governmental interest.
