

CMS has indicated general concerns about our current array of rehabilitative services. CMS comments were made in the context of the proposed rehabilitative services criteria. Specifically, they have questioned the school based Applied Behavior Therapy Services. CMS has indicated that this services appears to be habilitative rather than rehabilitative in nature.

School based Applied Behavior Therapy Services for individuals with Autism.

SC is still in discussions with CMS regarding ABTS. We are in the process of submitting other state plan amendments in response to CMS's request for a more detailed definition of state plan services.
