The regular monthly meeting of the Highways and Public Transportation Commission was held at the offices of the State Highways and Public Transportation Department in Columbia, South Carolina, at eleven o'clock a.m. on August 15, 1991. In compliance with the "Freedom of Information Act", the news media was advised in writing of the time, date and place of this meeting.

SECTION 1: The Minutes for the meeting of July 18, 1991; copies of which have been previously mailed to each member of the Commission, were approved.

SECTION 2: The Commission unanimously passed a motion approving purchase orders issued for amounts in excess of \$10,000.00 during the month of July, 1991, as shown in the Appendix.

SECTION 3: The Commission unanimously passed a motion authorizing the Department to enter into supplemental agreement No. 2 with Parsons, Brinckerhoff, Quade and Douglas to provide additional environmental services for the Grace Memorial Bridge in Charleston County at an estimated cost of \$329,000, as shown in the Appendix.

SECTION 4: The Commission unanimously passed a motion authorizing the Department to enter into supplemental agreement No. 4 with Wilbur Smith Associates, Inc. to provide additional wetlands and permitting studies on U. S. Route 52 in Berkeley and Williamsburg counties at an estimated cost of \$60,000, as shown in the Appendix.

SECTION 5: The Commission unanimously passed a motion authorizing the Department to negotiate and select a consulting engineering firm to provide statewide engineering services on an "on call" basis to include hydraulic and wetlands permits on a project by project basis at an actual cost plus fixed fee basis, as shown in the Appendix.

SECTION 6: The Commission unanimously passed a motion authorizing the Department to advertise and select a consulting engineering firm to provide engineering services for the Anderson Bypass/Connector for an estimated cost of \$4.5 million, as shown in the Appendix.

SECTION 7: The Commission unanimously passed a motion awarding building construction contract for the Oconee Maintenance Complex to Yeargin Enterprises, Inc. of Greenville for the low bid of \$2,044,444.00, as shown in the Appendix.

SECTION 8: The Commission unanimously passed a motion awarding building construction contract for the Columbia HQ Renovation - Parking Garage Repair to Homeowners Services, Inc. of Columbia for the low bid of \$47,976.00, as shown in the Appendix.

SECTION 9: The Commission unanimously passed a motion approving the allocation of \$67,500 of Urban Mass Transportation Administration (UMTA) Section 3 Discretionary Funds to the Lowcountry RTA, as shown in the Appendix.

SECTION 10: The Commission unanimously passed a motion amending the June 19, 1991 allocation of Public Transportation Funds, as shown in detail in the Appendix.

SECTION 11: The Commission unanimously passed a motion accepting a report of the Department concerning the execution of a quitclaim deed dated July 10, 1991 conveying 1.342 acres of land on U.S. Route 176 in Lexington County to U. T. McDaniel for the consideration of \$13,240.00, as shown in the Appendix.

SECTION 12: The Commission unanimously passed a motion approving the sale of scrap wooden pallets located at the Department's Supply Depot, Shop Road, Columbia, South Carolina, bids for which were received on July 8, 1991, as shown in the Appendix.
