Dear Governor Haley,

I had previously written to you on July 20, 2015 and January 4, 2016 regarding numerous violations of federal and South Carolina law by Pulte Homes, S&ME, Inc., and Blythe Engineering.


I am requesting that you once again review documentation on the enclosed CD which provides an updated account of these violations which includes the response to date of the SC LLR to my complaint filed against Pulte Homes (See the file "**1a) Summary of Pulte, S&ME and Blythe Violations**", p. 23-28.) A decision on the complaint against S&ME and Blythe is still pending investigation.

In these documents I demonstrate that these companies have violated and are presently violating federal and South Carolina law. As such it is necessary that the responsible governing authorities be aware of such violations. I submit that it is also your duty and responsibility to hold these entities accountable for those violations and take legislative action to safeguard the property and welfare of the citizens of South Carolina.

I need not elaborate on the details here. The documents in the numbered order support my claim of violations of the law in the residential construction industry and unethical business practices that compelled a grossly unfair process of legal counsel, mediation, and arbitration that only punished the claimants personally and financially rather than render them justice in a situation for which they had absolutely no responsibility. Here too, legislative action is needed to monitor, check, and remedy the practice and decisions of mandatory arbitration and arbitrators that show partiality to the large corporations who demand mandatory arbitration clauses in their contracts.
