Embattled New Jersey Gov. Chris Christie may no longer be at the front of the pack in the nascent race to be the 2016 Republican presidential nominee, but that's not preventing him from scheduling stops in the early voting states of Iowa and South Carolina.

**Note:** Christie – who chairs the Republican Governors Association – will fundraise on behalf of Iowa Gov. Terry Branstad and South Carolina Gov. Nikki Haley, both of whom are up for re-election this fall, the RGA confirmed to msnbc.

State Sen. Vincent Sheheen, the Democratic challenger for governor, has called for a special committee to investigate allegations that Republican Gov. Nikki Haley and her staff tried to obstruct a Senate probe into child deaths related to the S.C. Department of Social Services.

**Note:** Gov. Haley's office said neither she nor anyone on her staff intimidated panel members. "This is ridiculous election year politics and Vincent Sheheen should be ashamed of the way he is manipulating the deaths of children for his own benefit," Haley spokesman Doug Mayer said,

**Note:** Haley said she had no comment, but her office released a statement: "The difference between Gov. Haley and Vincent Sheheen is that the governor is actually working to prevent the deaths of more innocent children, while Vincent Sheheen views them as his political props of the week."

Bills that would outlaw abortion and strengthen South Carolina's open records law are among those unlikely to survive. Legislation that didn't advance from one chamber to the other by Thursday has little chance of becoming law this year.
