

MINUTES OF BUDGET AND CONTROL BOARD MEETING

JUNE 29, 1976

The Budget and Control Board met at 2:30 p.m. on June 29, 1976,
at the Governor's Conference Room with the following members in attendance:

MINUTES OF PREVIOUS MEETING - Board members were furnished with a copy of the minutes of the meeting of June 15, 1976, and, upon a motion by Senator Dennis, these minutes were accepted as written.

DEPARTMENT OF EDUCATION - SCHOOL BUILDING PROGRAM 1976-77 - Dr. Cyril B. Busbee, Superintendent of Education, and Ray W. Burnette, Deputy Superintendent, appeared to request the Board's formal approval of the funding of the State's school building program for fiscal year 1976-77. The lengthy discussion which followed Dr. Busbee's presentation focused on the General Assembly's intent, as reflected in Act R706, Acts of 1976, that the program continue in 1976-77 as it has in the past and on related procedural matters.

Upon a motion by Mr. Morris, seconded by Senator Dennis, the Board unanimously approved the request as presented by Dr. Busbee that the school building program be authorized to continue as it has in the past and that funds would be available on an as-needed basis, when owed and due to local districts, as in the past.

Data pertaining to this matter has been retained in these files and is identified as Exhibit I.

DEPARTMENT OF CORRECTIONS - CONSTRUCTION FREEZE - Dr. Hubert Clements, Deputy Commissioner for Administration, and Mr. Charles Leath, Deputy Commissioner for Operations, appeared before the Board to request approval of the completion of two dormitories at Goodman Correctional Institution. This construction was underway as of June 6, 1975, the date of the "freeze" on the issuance of capital improvement bonds, and it was being accomplished with inmate labor. No general contractor had been hired. Work on these dormitories subsequently was halted by the findings of the courts which held that bonds could be issued only to finance projects under contract as of June 6, 1975.

The funds needed to complete these two dormitories are included in the \$20,617,134 released to the Department of Corrections by R706, Acts of 1976, for "new and expanded facilities." This Act also contains the following provision: "That these funds shall be expended on projects as approved by the Budget and Control Board." The purpose of this proviso was to require the submission to the Board of a comprehensive plan by the Department of Corrections before these exempt funds are expended.

In presenting the request that the Board consider the approval of the completion of these two dormitories as a separate item apart from the required comprehensive plan, Dr. Clements and Mr. Leath assured the Board that no other significant exceptions would be requested prior to the completion of the plan in October, 1976. Dr. Clements and Mr. Leath also noted that the dormitories are now approximately 40% complete and that the additional space for 100 inmates which these two facilities would provide would help relieve the crowded conditions now existing at the Department's several institutions. Board members were also told that the increased operating costs related to these new facilities would not cause a budget deficit for the Department.

Board members unanimously approved a motion by Senator Dennis, seconded by Mr. LeaMond, authorizing the Department of Corrections to use up to \$250,000 of the total released to complete the two dormitories at Goodman Correctional Institution. This amount, plus \$159,586.12 expended on the project prior to the Court's findings, would bring the amount allocated for this project from the \$20,617,134 released by Act R706 to a total of \$409,586.12.

Data pertaining to this matter have been retained in these files and are identified as Exhibit II.

STATE HOUSING AUTHORITY - Mr. Steve Mayfield, Executive Director, and Mr. Charles Thompson, staff member, of the State Housing Authority appeared before the Board to request permission to advertise for and interview architectural firms which might be interested in designing housing projects for which the Authority will be designated as sponsor, owner and manager. Mr. Mayfield explained that it was the Authority's intention to economize on the costs of architectural services by developing prototype plans which could, with relatively little cost for re-siting, be used in several different locations. This would mean that a firm would be selected in each of several areas of the State to develop a prototype plan for use in one such area and that same firm would re-site these plans in various communities within the area as project approvals are granted.

In response to questions from Board members, Mr. Mayfield stated that the entire cost of these housing projects, including design, construction, maintenance and operational costs, would be financed by Federal funds and that no financial obligation of any sort is incurred by the State Housing Authority by virtue of its acting as the sponsor of such projects. Mr. Mayfield also assured the Board that the State Housing Authority has the legal authority, pursuant to the Housing Authority's original legislation enacted in 1971, to sponsor, own and manage such projects and that this statutory authorization is not in any way related to the litigation involving the Authority in recent years.

Messrs. Mayfield and Thompson indicated that notification of preliminary Federal approval of two projects, one to be located in Cowpens and another to be located in Walterboro, is expected within two weeks after which the State Housing Authority will have thirty days in which to submit architectural drawings for these projects.

After further discussion, Board members unanimously approved a motion by Senator Dennis, seconded by Mr. Morris, granting preliminary approval to the State Housing Authority's request for permission to proceed with advertising for and interviewing architectural firms on a geographic basis.

A copy of a letter from Mr. Mayfield relating to this matter has been retained in these files and is identified as Exhibit III.

STATE BOARD OF NURSING - APPROPRIATION FOR EXECUTIVE DIRECTOR - Mrs. Ella P. Garrison, President of the State Board of Nursing, and Mr. Kenneth L. Childs, staff attorney assigned to that Board from the Attorney General's Office, appeared before the Budget and Control Board to discuss problems related to the 1976-77 appropriation of \$16,500 for the salary of the Executive Director of the Board of Nursing. Mr. Childs and Mrs. Garrison noted that the Board of Nursing originally had allocated \$20,109 for this purpose for fiscal year 1976-77. This salary level had been set by the Board of Nursing for the former Executive Director who since has resigned. A new Executive Director was hired at a salary of \$16,500 on January 2, 1976, with the understanding that this salary would be reviewed within six months. Mrs. Garrison indicated that the new Executive Director has done an outstanding job and that a superior performance evaluation rating for the six-month period has been filed. Mrs. Garrison also noted that it was not until mid-June, when she inquired about her agency's budget, that she learned from the Auditor's Office that department head salaries had been held at the 1975-76 level but, by that time, General Assembly action on appropriations for 1976-77 had been virtually completed. For these reasons, Mrs. Garrison requested

that the Budget and Control Board approve increasing the Board of Nursing Executive Director's salary for 1976-77 from \$16,500 to \$17,820.

After considerable discussion in which Board members pointed out that the Budget and Control Board could not change line-item salary appropriations, Board members unanimously approved a motion by Senator Dennis, seconded by Mr. Patterson, that the salary for the Executive Director of the Board of Nursing be reconsidered in the preparation of the budget for the following fiscal year.

PATRIOTS POINT DEVELOPMENT AUTHORITY - REQUEST FOR APPROVAL OF LAND

ACQUISITION AS INVESTMENT OF INSURANCE RESERVE FUND - Upon a motion by Mr. LeaMond, Board members voted unanimously to add to the agenda a request by the Patriots Point Development Authority that the Budget and Control Board, pursuant to R720, Acts of 1976, acquire clear title to approximately three hundred acres of land which would become a part of the Authority's museum site. R720, Acts of 1976, authorizes the Budget and Control Board to acquire real property for use by the State as investments of reserve or sinking funds. Mr. Charles Hyatt, Chairman, and Admiral H. J. Kossler, USN-Retired, Executive Director, of the Patriots Point Development Authority, accompanied by Senator Allen Carter, appeared before the Budget and Control Board to discuss the request. Mr. Hyatt and Admiral Kossler explained that approval of the request would enable the Authority to proceed with the development of the Authority's museum site while arrangements for a permanent means of financing the acquisition were being worked out. Senator Carter indicated that a number of possible sources of financing, including seeking an appropriation from the General Fund, seeking an authorization for capital improvement bond funds or to issue revenue bonds, were being considered.

Upon a motion by Senator Dennis, seconded by Mr. LeaMond, the Budget and Control Board, pursuant to Act R720, Acts of 1976, approved the acquisition of clear title to approximately three hundred acres of land, as proposed by the Patriots Point Development Authority, as an investment of the Insurance Reserve Fund, to be repaid by means of a permanent financing plan to be worked out with the State Treasurer and the State Auditor. Because of a possible conflict of interest, Governor Edwards did not participate in the discussion of this request and asked to be recorded as not voting on the motion.

NUCLEAR ADVISORY COUNCIL - ATTORNEY SERVICES - Upon a motion by Senator Dennis, the Board agreed without objection to add to the agenda a request by the Nuclear Advisory Council that it be allowed to establish an attorney position and to transfer appropriated funds as necessary to enable the Council to fund such a position. Mr. Edward J. Hennelly, Vice-Chairman, and Mr. James W. Burch, Council Coordinator, of the Nuclear Advisory Council, presented the request to the Board, stressing the importance of continuing legal counsel to the work of the Council. Mr. Hennelly stated that the Attorney General previously has informed the Council that his Office is unable to supply the services needed.

In the ensuing discussion, Board members noted that the Free Conference Committee eliminated a proviso which would have required the Attorney General to assign and physically locate at least one of his Assistants to perform necessary legal work for the Council and that the Free Conference Committee also eliminated a requested appropriation for a classified position in the legal field for the Council.

Board members unanimously approved a motion by Senator Dennis, seconded by Mr. Morris, that the Budget and Control Board request the Attorney General to provide the legal services needed by the Nuclear Advisory Council until the General Assembly can reconsider the matter at its next session.

A copy of a letter from Mr. Burch pertaining to this matter has been retained in these files and is identified as Exhibit VI.

PERSONNEL DIVISION - COMPENSATION PLAN FOR TECHNICAL AND COMPRE-
HENSIVE EDUCATION - Dr. Jack Mullins presented and recommended the Board's approval of a revised compensation plan for unclassified employees of the Technical and Comprehensive Education system designed to reflect increases approved by the General Assembly in recent years. The revised schedule increases the minimums of the salary range by 4% and increases the maximums by 10% effective July 1, 1976.

Upon motion by Mr. Morris, seconded by Mr. Patterson, the Board unanimously approved the revised compensation plan for unclassified employees of the Technical and Comprehensive Education system.

Data pertaining to this matter has been retained in these files and is identified as Exhibit VII.

BLUE CROSS - BLUE SHIELD CONTRACT FOR FISCAL YEAR 1976-77 - Upon a motion by Mr. Patterson, the Board agreed without objection to add to the agenda a request by Dr. Jack Mullins, Director of the State Personnel Division, that the Board approve the renewal of the Blue Cross - Blue Shield health insurance contract for Fiscal Year 1976-77. In recommending that the Board approve the contract renewal, Dr. Mullins called attention to the few modifications made to the existing contract and to the approval of the revised contract by the Department of Insurance and the Budget and Control Board's consultant on this matter.

The Budget and Control Board approved unanimously a motion by Mr. LeMond, seconded by Mr. Patterson, that the contract with Blue Cross - Blue Shield, as modified for Fiscal Year 1976-77, be approved subject to final approval and execution by Governor Edwards.

Data pertaining to this matter has been retained in these files and is identified as Exhibit VIII.

MOTOR VEHICLE MANAGEMENT DIVISION - Mr. Allen Spence, Director of the Motor Vehicle Management Division, requested the Board's approval of the following automobile purchases:

- One Mercury Marquis - Highway Department
- One Chevrolet Impala or the equivalent - State Auditor's Office
- One Plymouth Sedan - House of Representatives
- One Plymouth Sedan - Senate
- One Sedan - Tax Commission

Upon a motion by Mr. Patterson, seconded by Mr. Morris, the Budget and Control Board approved the purchases as presented.

GENERAL SERVICES DIVISION - Mr. Furman McEachern, Director of the General Services Division, recommended approval of the following requests for authorization to purchase printing equipment:

- A. Department of Labor - One Bostitch #7 Saddlestitcher at an approximate cost of \$1,900.
- B. State Board for Technical and Comprehensive Education - One Triumph Model 21E electric paper cutter at an approximate cost of \$1,900 for use at the Trident Campus.
- C. Vocational Rehabilitation - Replacement of manual paper cutter with an electric model at an approximate cost of \$3,400.

The Budget and Control Board unanimously approved a motion by Mr. Patterson, seconded by Mr. Morris, that these purchases be approved as presented.

FOREIGN TRAVEL - The Budget and Control Board approved unanimously a motion by Mr. Morris, seconded by Mr. LeMond, approving the following foreign travel requests:

- A. Professor Gilbert R. Gredler, University of South Carolina, to travel to Durham, England from July 10 through August 2, 1976, to attend the 23rd Conference of the United Kingdom Reading Association. Three hundred dollars of the total cost of this trip are to be provided from State appropriated funds.
- B. Professor William C. Barnwell, University of South Carolina, to travel to Dublin, Ireland from July 9 through July 19, 1976, to interview Francis Stuart in connection with a series of works on Modern Irish Poets and to research obscure periodicals at Trinity College. Transportation costs of \$497 are to be paid from State appropriated funds.

- C. Dr. William Trotter, University of South Carolina, to travel to Paris, France from July 6 through July 13, 1976, to participate as a principal speaker at the Conference on Combinatorial Problems and Graph Theory. Transportation costs of \$560 are to be paid from State appropriated funds.
- D. Professor Charles F. Kovacik, University of South Carolina, to travel to Moscow, USSR from July 27 through August 4, 1976, to participate in the Congress held by the International Geographical Union. Total cost of this trip is estimated to be \$1,612 and \$600 of this total are to be paid from State appropriated funds.

Additionally, upon a motion by Mr. LeaMond, seconded by Mr. Morris, the Budget and Control Board approved unanimously the following foreign travel requests:

- E. Dr. Raghaven M. G. Nair, Medical University of South Carolina, to travel to Hamburg, Germany from July 18 through July 31, 1976, to participate in the International Congress of Endocrinology and the International Congress of Biochemistry. No State appropriated funds will be used for this travel.
- F. Dr. S. S. Spicer, Medical University, to travel to Bucharest, Romania from August 29 through September 3, 1976, to present a paper to the International Congress of Histochemistry and Cytochemistry. No State appropriated funds will be used for this travel.
- G. Dr. J. M. Shively, Clemson University, to travel to Hamburg, Germany from July 21 through August 16, 1976, for research purposes at Hamburg University and to present a paper at the International Congress of Biochemistry. No State funds are involved.
- H. Dr. John Y. LeBourgeois, Clemson University, to travel to London, England from June 27 through August 9, 1976 for research purposes. No State funds are involved.
- I. Dr. Herbert W. Busching, Clemson University, to travel to Cairo, Egypt from November 13 through November 22, 1976, to present a paper at the Cairo Workshop on Evaluation of Industrialized Housing Systems. No State funds are involved.

FUTURE BUDGET AND CONTROL BOARD MEETING - Board members unanimously agreed that the next meeting should be held at 2:30 p.m. on July 14, 1976.

UNIVERSITY OF SOUTH CAROLINA - SELECTION OF ARCHITECTS - A request from the University of South Carolina to hire an architectural firm for the Student Union Building project at Coastal Carolina, presented to the Budget and Control Board at its June 15, 1976 meeting, had been carried over in order that additional information might be supplied to the Board. The University of South Carolina, after meeting all legal requirements for the selection of architects or engineers, had selected and ranked in order of preference the following three firms from among those interviewed:

1. Riddle and Wilkes
2. Lucas and Stubbs
3. Gill and Wilkins

The additional information supplied to the Board indicated the firm ranked number one by the University of South Carolina, Riddle and Wilkes, had performed five of the last seven A/E contracts accomplished at Coastal Carolina. In the ensuing discussion, Board members pointed out that approval of Riddle and Wilkes firm in this instance would be contrary to the objective "of effecting an equitable distribution of contracts among qualified firms..." as expressed in the statute containing the procedure to be followed in selecting architectural or engineering firms.

Upon a motion by Senator Dennis, seconded by Mr. Patterson, the Budget and Control Board unanimously approved the firm of Lucas and Stubbs for the Student Union Building project at Coastal Carolina.

Data relating to this matter have been retained in these files and are collectively identified as Exhibit X.

EXECUTIVE SESSION - Governor Edwards announced that three items, one relating to the salaries of unclassified personnel, one relating to the salary of the Executive Director of the Residential Home Builders Commission and one relating to an employee grievance matter had been proposed for consideration in Executive Session. Without objection, Budget and Control Board members agreed to declare the Board meeting in Executive Session.

Dear Governor Edwards:

Part II of Senate Bill 827, R 706, authorizes continuance of the State School Building Program in 1976-77 at the per pupil amount provided in 1975-76 with the Program to be financed by General Fund Appropriations and State School Bonds. The Act states in part, "In the event that an appropriation for such funding has not been enacted by the General Assembly prior to February 1, 1977, the Budget and Control Board on or after that date is authorized to approve the issuance of school bonds in an amount not to exceed fifteen million six hundred thousand dollars, under the provisions of existing statutes authorizing school bonds, and notwithstanding any other limitation of law that may preclude or restrict the issuance of school bonds."

The State Board of Education at its meeting held on June 11, 1976 directed the State Department of Education to request the Budget and Control Board to approve the issuance of such amount of the \$15,600,000 in State School Bonds authorized to be issued as may be necessary to finance the program in accordance with the action of the General Assembly. AN ACT

To Amend Act 1377 of 1968, as Amended, Relating to State Capital Improvement Bonds, so as to Authorize Issuance of Certain Additional Bonds and Increase the Aggregate Principal Indebtedness Authorized by the Act; to Authorize Certain State Agencies to Proceed with Certain Projects in Accordance with Schedules Established by the State Budget and Control Board; and to Authorize the Issuance of Additional Bonds to Fund the Projects Which Are Authorized to be Undertaken Pursuant to this Act.

Be it enacted by the General Assembly of the State of South Carolina:

Part I

SECTION 1. Item (f) of Section 3 of Act 1377 of 1968, as last amended by Act 237 of 1975, is further amended by adding additional subitems, to be appropriately numbered, which shall read:

- "() Adjutant General's Office
Architectural and Engineering fees for armories
in Winnsboro, Kingstree, Lyman and Marion. 37,454.00
- () School for the Deaf and Blind
Alarm and Sprinkler System 150,000.00"

SECTION 2. Section 4 of Act 1377 of 1968, as last amended by Act 237 of 1975, is further amended by striking the cumulative total and inserting "\$504,648,569.00". The section as amended shall read:

"Section 4. The aggregate principal indebtedness on account of bonds issued pursuant to this Act shall not exceed \$504,648,569.00; provided, that the limitation herein imposed shall not apply to bonds issued on behalf of the Mental Health Commission as provided in Act No. 1276 of 1970 and Act No. 1272 of 1970, or bonds issued on

behalf of the Commission on Mental Retardation as provided in Act No. 1087 of 1970. The limitation herein imposed shall not be deemed to be an obligation of the contract made between the State and holders of bonds issued pursuant to this Act, and the limitation herein imposed may be enlarged or reduced from time to time by acts amendatory hereof. Within such limitations State Capital Improvement Bonds may be issued from time to time under the conditions prescribed by this Act."

In the event that an appropriation for such funding has not been enacted by the General Assembly prior to February 1, 1977, the Budget and Control Board on or after that date is authorized to approve the issuance of school bonds in an amount not to exceed fifteen million six hundred thousand dollars, under the provisions of existing statutes authorizing school bonds, and notwithstanding any other limitation

of law that may preclude or restrict the issuance of school bonds. _____

Pursuant to our telephone conversation on Monday morning, I am writing to explain the Authority's need to act promptly in the selection of architects for State Housing Authority-sponsored projects financed by Farmers Home Administration (FmHA) and assisted by the Department of Housing & Urban Development (HUD) Section 8 Housing Assistance Payments. The State Office of the Farmers Home Administration and the Columbia Area Office of HUD are presently reviewing two projects for which the State Housing Authority is the designated sponsor/owner/manager. The Authority's Commissioners, at their May 11, 1976, monthly meeting, authorized the State Housing Authority to serve as a bona fide sponsor in connection with the HUD Section 8/FmHA Section 515 projects.

The State Housing Authority is authorized to participate as a sponsor of FmHA Section 515 projects under the provisions of the Housing & Community Development Act of 1974 and has been approved to receive HUD Section 8 funds according to a special set-aside provision as a "State Housing Finance and Development Agency (SHFDA)." HUD's determination of the Authority's qualification as a SHFDA was based upon a May 29, 1974, letter from Assistant Attorney General M. Elizabeth Crum citing the Authority's powers as specified in its 1971 legislation. Thus, the State Housing Authority's participation in the Section 8/515 program is based on its 1971 legislation and is not dependent upon its unconstitutional 1974 and 1975 legislation or the General Assembly's action on its 1976 legislation.

Based upon information that we have received just last week, the Authority should be receiving notification that preliminary approval on State Housing Authority-sponsored projects

in Cowpens and Walterboro will be granted within two weeks. After this notification, the Authority has thirty (30) days in which to submit architectural drawings. As you are aware, we have been developing acceptable preliminary applications and sketch plans based upon drawings done by a non-architect Authority staff member. The Authority's submission for final HUD architectural approval must be accompanied by architectural drawings developed by a registered architect selected by the Authority. Unless architects are selected on a contingency basis prior to HUD approval of our preliminary application, the 30-day deadline will make it virtually impossible for us to meet HUD requirements for final architectural drawing submission.

Thus, I am requesting that the Authority be authorized immediately to advertise for architects on a contingency basis because of the commitments and submissions that have already validly been made in the name of the Authority.

Mr. Mills at the Budget and Control Board suggested I write you a letter explaining some circumstances about the budget submitted to the Budget and Control Board from the Board of Nursing for 1976 - 1977.

We submitted the budget prior to the resignation of our Executive Director, Hazel Peeples. In the budget we had allocated \$20,109 for her salary (this included a merit raise). Our present Executive Director, Ruth Q. Seigler, was hired January 2, 1976, at \$16,500 and promised review in 6 months, which is July 2, 1976.

When I asked for our budget from the Auditor, I noticed the figure under Executive Director had been changed to \$16,500 for 1976 - 1977. I called Mr. Garvin on Friday, June 11, 1976, and he said the State Auditor has instructed that all department heads be frozen at this year's salary. Needless to say, the Board of Nursing is very concerned that our budget was changed without our knowledge and that we did not have the opportunity to include a merit increase for Mrs. Seigler.

I hope you and the Budget and Control Board will give this request prompt consideration and a favorable answer. Since we do have the funds, the Board of Nursing requests that this figure be changed from \$16,500 to \$17,820. This would give Mrs. Seigler a total of an 8% increase, which would include a cost of living increase. She is doing an outstanding job and her 6 month evaluation is on file as Superior. This Board does know and feels this salary is well in line with executives of other Boards.



As a follow-up to my letter of May 20, 1976, this is to request that the State Budget and Control Board authorize Patriots Point Development Authority the use of \$350,000 from the reserve or sinking fund of the State to purchase the remaining land claims at Patriots Point.

Acquisition of title claims to the remaining 317 acres at Patriots Point is the first priority requirement for the Authority now that the Yorktown is in place. The price of \$1100 per acre has been paid by the Authority for the similar title claims of other individuals to the first two parcels on Patriots Point totaling about 210 acres. Prompt purchase or condemnation of the remaining claims is critical for two reasons: (a) land values are soaring in the area (now up to \$11,000 per acre for high land across Highway 17 from Patriots Point), and (b) essential development of support facilities at Patriots Point to assure that income no longer be delayed.

Unless income producing leases and concessions as outlined in the development plan are negotiated in the immediate future, the entire future of the park will be jeopardized. These leases and concessions will require complete ownership of the entire Patriots Point area by the State, which now has only a disputed claim to title to the 317 acres in question. An Act To Authorize The Use Of Certain Reserve Or Sinking Funds Of The State To Purchase Property And To Repeal Act 1274 Of 1970 Relating Thereto.


Be it enacted by the General Assembly of the State of South Carolina :

SECTION 1. The Budget and Control Board on behalf of the State may acquire for use by the State real property as investments of any reserve or sinking fund of the State which is not pledged for payment of bonded indebtedness. *Provided*, however, such expenditures from the reserve or sinking fund shall not exceed two million dollars. Upon any such acquisition the Budget and Control Board shall execute a note evidencing such investment upon such terms and conditions as may be appropriate in each instance. The note shall include a pledge of the Board to apply on its payment all net income derived from the property so acquired; *provided*, that funding for any permanent project on the property shall provide for repayment of any outstanding balance to the appropriate reserve or sinking fund. *Provided*, further, that the purchase price of any property so acquired, including improvements existing or proposed, shall not be in excess of the actual value thereof as established by at least two appraisals satisfactory to the said Board. Any property not put to permanent use by the State or one of its agencies or departments within six years shall be sold at public auction and the proceeds repaid to the appropriate reserve or sinking fund. *Provided*, further, that no property shall be acquired pursuant to the provisions of this act when the grantor has entered into a contract with any county, city or other political subdivision which created a tax obligation with respect to the property and such obligation has not been resolved to the satisfaction of the county, city or other political subdivision involved.

Provided, that prior to purchasing, or contracting to purchase any real property the Budget and Control Board shall engage an independent engineer to make borings so as to insure that the property is adaptable to the contemplated use.

SECTION 2. Act 1274 of 1970 is repealed.




In addition to the Naval and Maritime Museum, a Master Plan has been prepared for the continuing development of all of the Patriots Point Complex. The Oceanarium will consist of a flexible arrangement of tanks and live specimen, with special exhibition and research facilities. The Aquatic Theater will feature dolphin shows and other attractions.



There will be an amphitheater for outdoor presentations of an educational and recreational nature, which will overlook Charleston Harbor and the old section of Charleston. The Marina will have motel facilities, and will be readily accessible to the Inland Waterway. A Seaman's Chapel is planned to honor those who made the supreme sacrifice for their country. And there will also be flower gardens, parks, scenic walks, bicycle trails, restaurants concessions and other facilities.

Patriots Point is located at the East end of the Cooper River Bridge, which serves to connect Charleston with the City of Mount Pleasant, just south of U. S Highway 17.

The Aircraft Carrier Yorktown served her country well from WW II through Korea and Vietnam. The WW II record of "The Fighting Lady" included 2358 Aircraft damaged or destroyed, 118 enemy ships sunk (244,770 tons), and an additional 329 ships (820,693 tons) damaged. Yorktown was wounded only once, and that occurred on 18 March, 1945, while conducting bombing raids on Japan. An enemy plane dropped a bomb on Yorktown's starboard signal bridge, which passed through the deck, and exploded alongside in the vicinity of the second deck, killing 3 men and wounding 18.

In July, 1974 the Navy Department and the Congress approved the application of the Patriots Point Development Authority for the Yorktown. The contract was signed by the Secretary of the Navy Middendorf, and Governor Edwards of South Carolina, at a ceremony at the Capitol in Washington on 8 May, 1975. The Yorktown was towed to Charleston from Bayonne, New Jersey, arriving on 15 June, 1975, and was dedicated as the first ship of the Naval and Maritime Museum on 13 October, 1975, the 200th birthday of our Navy.

It is eventually planned to use the Flight Deck of the Yorktown for the display of Navy Planes. On the Hangar Deck will be built a museum to tell the story of the Naval and Maritime Heritage of our Country, and a Theater for showing movies of past actions and historical events in which the Navy was involved. A model showing how this Museum will eventually look, is displayed on board.

Until the Museum can be completed, the Hangar Deck will be utilized for the display of planes, weapons, ship models, plane models and other items of interest. Certain compartments in the superstructure and below decks will be opened to show visitors how the crew lived and worked aboard ship. And as time and money permits, additional compartments will be opened, and a Navy and Maritime Library will be built. It is also hoped that other Aircraft Carrier Associations will refurbish rooms on board, as was done by the Yorktown Association. It is planned to dedicate certain rooms to individuals and veteran groups, as we did in "The Chairman's Room", honoring the late Congressman L. Mendel Rivers.





The Yorktown is the first ship of several decommissioned ships, which will comprise the Naval and Maritime Museum. It is planned to add a Submarine, Destroyer, Cruiser, Merchant Marine Ship, Coast Guard Ship and others.

Most Americans are not aware of the important role that Mine Warfare has played in the History of our Navy. The deeds of the brave men assigned to this type duty receive little publicity. It was this small unit of Navy men that recently swept the mines in North Vietnam and the Suez Canal. A Harbor Minesweeper, and the gear used for sweeping mines, is planned for display near the Yorktown.



Displayed on the Hangar Deck of the Yorktown are Mines dating back to Civil War days, together with information on how they operate.



LOCATION

Patriots Point is located at the East end of the Cooper River Bridge, which connects the cities of Charleston and Mount Pleasant just south of U.S. Highway 17.

Accessibility is excellent. The Site can be reached by using the Interstate System and Highway 17 without a single traffic light. It can also be reached by boat through the Intracoastal waterway, and it is only 13 miles from the Municipal Airport.

The site affords an unobstructed view of Charleston, Fort Sumter, Fort Moultrie and other places identifiable in the American Heritage.

FUTURE PLANS

The Yorktown Memorial Theatre, where films will be shown of the Yorktown in action, is scheduled to open this summer.

It is also planned to start work on The Enlisted Mess and Galley; Uniform Room; Bunker Hill, Wasp and Saratoga Rooms, honoring those men who served in these famous Aircraft Carriers; The Tailhook Association Room, honoring all pilots who flew from Carriers; The Butcher Shop, Print Shop, Bakery, Machine Shop, Post Office, Engine Room and other spaces. A date has not yet been set for starting the Hangar Deck Museum.

Within the Naval and maritime Museum, Patriots Point we plan to add a Destroyer, Cruiser, Submarine and possibly a Battleship, Coast Guard Ship and a Merchant Marine Ship.

HISTORY OF THE U.S.S. YORKTOWN

April 1943 - July 1943 - Training

July 1943 - September 1945

Engaged in WWII and was awarded the Presidential Unit Citation, fifteen battle stars, and other awards for operations against the Japanese in the Pacific.

September 1945 - January 1947

Engaged principally in returning veterans home from Pacific Bases. Decommissioned and placed in the Reserve Fleet on 9 January 1947.

January 1947 - December 1952

In the Reserve Fleet. Removed from the Reserve Fleet and recommissioned on 15 December 1952.

December 1952 - June 1970

Engaged in the Korean War for which she was awarded the Korean Service Medal and the United Nations Service Medal and in the Vietnam War, for which she received the Armed Forces Expeditionary Medal and the Vietnam Service Medal. And she picked up the Astronauts following the successful Apollo 8 Space Mission.

June 1970 - June 1975 - In the Reserve Fleet

9 June 1975 - Under tow from Bayonne, New Jersey to Charleston.

15 June 1975 - Moored at Patriots Point.

13 October 1975 - Dedicated on the 200th Birthday of U.S. Navy as the first ship in the Naval and Maritime Museum.

3 January 1976 - Opened to the public.

The Yorktown was commissioned on 4 April 1943, with Mrs. Franklin D. Roosevelt serving as her sponsor. She earned the reputation as an "Eager Ship" at her launching on 21 January 1943 in Newport News, Virginia, when she started down the launching ways five minutes ahead of schedule. Mrs. Roosevelt quickly stepped forward and smashed the bottle of Champagne just in time, to the accompaniment of cheers from surprised guests and spectators.

The Yorktown has an overall length of 872 feet; extreme width at the flight deck is 147 feet 6 inches, displacement 27,100 tons; draft of 28 feet 7 inches; and a speed of 33 knots. She was designed to carry 360 officers and 3088 enlisted men, and more than 80 Aircraft.

During her wartime service Yorktown's guns shot down 14 enemy aircraft, and her aircraft shot down 458 of the enemy aircraft and destroyed 695 on the ground.

PROGRESS IN THE DEVELOPMENT OF PATRIOTS POINT

The Patriots Point Development Authority was created by the General Assembly for the specific purpose of developing at Patriots Point a Naval and Maritime Museum, together with supporting educational and recreational facilities.

During the first phase of the development it was planned to purchase the claims to 130 acres of land on which the Yorktown would be moored. However, due to the successful negotiations conducted by the State's Attorney General's Office, it became possible to obtain approximately 210 acres at a cost of about \$1100 an acre.

Work to date at Patriots Point has been focused on the development of the Naval and Maritime Museum on board the Yorktown. The goal from the beginning was to have the work far enough along, within the constraints of time and money, so as to permit opening the Yorktown to visitors during our Bicentennial year.

Subsequent development at Patriots Point will require acquisition of the approximately 317 acres of land remaining at Patriots Point. The entire 500 acres is essential to assure the kind of public-private interactive success which we anticipate.

Major funding for the initial development of Patriots Point was managed through the backing of the State in obtaining a loan of three million dollars. This has been spent to purchase the 210 acres of land, dredging, pier construction, utility construction, a sewage plant, towing, painting and services of architects, engineers and consultants. The Budget and Control Board has directed that the three million dollars be repaid to the State over a 21 year period, with only the interest the first year, which is Fiscal Year 1977.

Additional funding of \$350,000 is required to purchase the land claims at Patriots Point for the remaining 300 acres. A request for the money to purchase these claims was included in the Patriots Point FY1976 and FY1977 budget submissions. However, it was deleted by the State Auditor's Office.

This land must be obtained so that income producing leases and concessions can be negotiated, so as to add to the income now being generated by the Yorktown. This will permit further development of the Museum and Patriots Point. In order for the Naval and Maritime Museum to realize its full potential, large expenditures of capital funds must continue in the future. Because in addition to the two million dollar Museum to be built on the Hangar Deck, and the million dollar Library, it is hoped to add a Submarine, Lightship, Destroyer, Merchant Ship, and possibly other ships to the Museum.

Acquisition of title claims to the remaining acreage at Patriots Point is the first priority requirement for the Authority. Prompt purchase or condemnation of these claims is critical, because unless income producing leases and concessions are soon negotiated, the entire future of the park could be jeopardized. These leases and concessions will require complete ownership of the entire area by the State, which now has only a disputed claim to the 317 acres in question. And for only \$1100 an acre this claim can be converted into an undisputed fee simple title, and provide critically needed land for the project at Patriots Point.

As mentioned above, only the interest on the three million dollar loan, about \$150,000, must be repaid in Fiscal Year 1977. However, in Fiscal Year 1978, when payments on both the principal and interest will be required, income from the Yorktown alone will not be sufficient to make this payment, as well as pay for the operation and maintenance of the Yorktown. Therefore, additional income must become available from the leasing of land for the facilities at Patriots Point.

The Patriots Point Development Authority is one of the few State Agencies that brings revenue to the State of South Carolina. And as Patriots Point is further developed, more tourists will be attracted to the State, and revenue will increase proportionately. Since opening to the public on 3 January, and through the month of May, the Authority has paid approximately \$9000 to the State in admission and sale taxes. In addition, interest on admission funds deposited in the General Fund has amounted to about \$3500. And I might add, sales taxes paid on supplies and equipment purchased with the borrowed three million dollars amounted to \$20,000. In addition, all employees pay State Income tax.

During the three years that the Patriots Point Development Authority has been in existence, a determined effort has been made to keep costs to a minimum. The State Ports Authority has provided free office space to the staff of the Authority, and the Charleston County Parks, Recreation and Tourist Commission has provided clerical and other administrative support. The Staff has no official vehicles, no trucks for transportation of equipment and supplies, and no slush funds of any sort.

All of the staff duties of the Patriots Point Development Authority are performed by the following three persons:

Dear Mr. Putnam:

The Council, under the provisions of Section 2 (1) and (4), Act 302, 1973, is required to represent the State in licensing proceedings before the United States Nuclear Regulatory Commission for nuclear facilities located in the State and participate to the fullest extent possible in national rule making hearings or proceedings concerning changes to Nuclear Regulatory Commission regulations. To provide adequate representation for the State, the Council requires the services of an attorney, without which the Council believes it cannot fulfill its statutory responsibilities.

Act 302 specifies that an attorney from the Office of the Attorney General "shall be available at all necessary times to advise" the Council. In the attached letter Attorney General McLeod states that the Council needs the services of a full-time attorney and that it is manifestly impossible for him to make an attorney available to the Council.

Monies were requested from the State Legislature to employ an attorney, but the funds were removed from the Council's budget on the recommendation of the Committee of Free Conference.

Due to the importance of and the controversy surrounding the licensing of the Barnwell Nuclear Fuels Plant, the upcoming Nuclear Regulatory Commission's generic hearings on the recycle of plutonium oxide reactor fuels, and Westinghouse's Recycle Fuel Plant proposed for Anderson County, the Council believes it imperative to have legal representation at this time.

Because of postponement of and delays in the several federal proceedings in which the Council should be participating, the Council believes that its FY 1976-77 appropriation contains sufficient funds to pay for the services of a qualified attorney. The Council, therefore, respectfully



Dear Mr. Burch:

Your letter of recent date requests the assignment of an Assistant in this Office to the Nuclear Advisory Council and I have had Mr. Beighley, Assistant Attorney General, discuss this matter with you following receipt of your letter.

It is apparent that your Council needs a full-time attorney with the necessary interest and expertise to go forward and actively represent the interests of the State in nuclear matters. Such an attorney should have an engineering background, if possible, to adequately cope with the technical scope of this complex area. From information furnished by you, it is apparent also that the duties of this attorney would include attending Nuclear Regulatory Commission hearings for approximately 100 to 200 days per year, and representing the State as a party at these hearings. In addition, the attorney would need to develop a research file sufficient to provide background data and would need to study existing and proposed federal nuclear regulatory laws. He would also make repeated and prolonged trips to Washington on nuclear-related matters and he should also be ready to take legal action, when necessary, to insure compliance with all State nuclear regulations in cooperation with DHEC's Radiological Health Division.

Section 1-400.26 of the Code of Laws, 1962, provides that an attorney employed in this Office, with specialized knowledge, shall be available at all necessary times to advise the Council in the performance of its duties.



With the load imposed upon the staff of this Office at the present time, it is manifestly impossible to undertake the assignment of an individual, assuming that he had the requisite qualifications, to your Council on what is clearly a highly specialized and full-time basis. The experience of Mr. Randolph Mahan, Assistant Attorney General, demonstrates this, as it proved impossible for him to carry out his duties with the Department of Health and Environmental Control and, at the same time, attempt to provide counsel in your area.

It is obvious to me that a selected individual must be provided for if the requirements of your agency are to be met. In the present economic posture, it is extremely doubtful if additional monies for such an Assistant can be procured through this Office. My staff is presently stretched to the limit of its capacity. To provide these needed services, it is my suggestion that efforts be made to procure funds for the employment of a suitable attorney to be housed either in your offices or in the Department of Health and Environmental Control, and I will be pleased to join with you in any efforts to remedy the situation in this manner or in any other feasible manner.



Dear Mr. Chairman:

Blue Cross and Blue Shield of South Carolina is pleased to renew the contract with the State of South Carolina for the new contract year beginning July 1, 1976 through June 30, 1977. The computation for the renewal rates have been presented to the Board previously and accepted. These rates were in consideration of minor modifications of the ongoing and existing contract. The existing contract will be modified as follows:

1. Schedules A of the contract for active and the one for the retired employees (see the attached new schedules) are replaced in their entirety showing the new premiums. Also included on this schedule is our financial arrangement for the period indicated. Note that under this arrangement Article VIII, Paragraph 1, Page 19 of the active contract and page 11 of the retiree contract has been modified.
2. Article I, Definitions, Page 1, of our existing contract is replaced with the following: Paragraph 11 "Physician" means duly licensed Medical Doctor (M.D.), Doctor of Dental Surgery (D.D.S), Podiatrist (D.P.M.) and Doctor of Osteopathy (D.O.), (not to include an intern or resident or house physician), legally entitled to practice medicine or surgery or dentistry within the scope of his or her license and who customarily bills patients for his or her services.
3. Article VII, Paragraph 2, Page 19 is deleted in its entirety and replaced by the following:
 2. In the event an Employee ceases to be in the Employ of the Employer or in the event the Employer notifies the Corporation that coverage of an Employee is to be terminated, or in the event this contract is cancelled by the Employer or the Corporation, the coverage respecting such Employee and all of his or her Dependents shall terminate automatically at the end of the period for which the payment of premium shall have been made by the Employer for such Employee. (See Article X for Conversion Privileges.) However, maternity benefits will be paid where delivery occurs prior to the Termination of the Contract, provided the employee has served a 270 day waiting period.





We are requesting Budget and Control Board approval for travel to Moscow, July 27 - August 4, 1976 for Professor Charles R. Kovacik. The total cost of the trip is estimated to be \$1612., of which \$600. is proposed to be subsidized by State appropriated funds. The balance will come from personal funds and a grant from NSF.

Every four years the International Geographical Union holds a Congress in which the world's leading geographers participate. The 23rd International Geographical Congress will be held in the USSR in July - August 1976.

Professor Charles F. Kovacik is one of six faculty in the Geography Department to have a paper accepted for the Congress in Moscow, July 27 - August 4, 1976. He is one of 12 nationally, and the only person from the South to be awarded an NRC travel grant for this Congress out of a total of almost 100 applicants. NRC foreign travel grants are this year restricted to \$500 with the expectancy that the grantee's institution will contribute in meeting the high costs of participation in International Conferences -- estimated to be about \$1,600 in Kovacik's case. Consequently Kovacik will not be able to go unless these funds are approved.


Five of the current USC members, including Kovacik, read papers at the 22nd Congress in 1972 in Montreal, Canada. All indications are that over 2,000 geographers will attend the Congress, with about 100 from the U.S.A.

Kovacik's paper "Land Use on the South Carolina Plantation Lands," will be published and will be read in Section IX-Historical Geography in which the leading historical geographers will participate. The plantation lands topic represents a continuing effort by Kovacik in research and course development into the historical and cultural geography of the rural areas of this state, and blends in well with the general emphasis in this department on the analysis of problems






