I hope you are doing well. As we discussed earlier this year, SCDNR and SCDHEC are the state trustees for CERLCA actions involving Natural Resources Damages (NRD) claims. We are currently working on finalizing an NRD claim for the Charleston area referred to as Koppers. Attached is the MOA that we would like you to review and sign so that we can move forward with the Koppers NRD claim. In looking back at our files, I also think that we are missing an updated letter appointing Director Alvin A. Taylor for SCDNR and Director Catherine E.
