Pending later disposition of the matter, the Commission agreed to provide a salary for the Executive Assistant of the Tax Commission on a 30-day notice basis at the rate of \$4000.00 per annum.

The Secretary was instructed to advise the South Carolina Council of Defense and Colonel J. D. Fulp that the Commission did not recommend continuation of Colonel Fulp's duties in Washington beyond July 31 1943. The

Commission recommended that this salary be paid for the month of July from the appropriation for Industrial Development and Laboratories carried in the section of the Council of Defense.

Application was made to the Budget Commission by the State Hospital, the State Training School, and the John De La Howe School for use of additional funds under the terms of Section 117 of the 1942-43 General Appropriation Act. The following additional appropriations were approved by the Commission as provided in this Section:

The State Training School	15,000.00
The John De La Howe School	2,000.00
