Katherine,

To recap what we just discussed, the Governor's Office will proceed with appointments in (c), (d), (e) and (f) as pasted below; House and Senate appointments are already under way.  
You will be getting with Ted Pitts to discuss the rollout plan, and anticipate sending an announcement upon receipt of all appointee names, to include soliciting input for establishing in initial meeting date.

As you requested, the Senate appointments for the H.3428 Study Committee are as follows: Senators Fair, Hembree, Setzler and Thurmond, and we will send you a more official notice of these appointments. Rep. Allison and G. Smith have contacted you regarding their respective House appointments, and you are awaiting the other two.

Thank you, and please let me know if you need anything else.

(2) The study committee shall be composed of:

(a) four members of the Senate appointed by the Chairman of the Senate Education Committee. Of these members, one must be appointed upon the recommendation of the Senate Majority Leader, one must be appointed upon the recommendation of the Senate Minority Leader, and one must be a member of the South

Carolina First Steps to School Readiness Board of Trustees;

- (b) four members of the House of Representatives appointed by the Chairman of the House Education and Public Works Committee. Of these members, one must be appointed upon the recommendation of the House Majority Leader, one must be appointed upon the recommendation of the House Minority Leader, and one must be a member of the South Carolina First Steps to School Readiness Board of Trustees;
- (c) one member appointed by the Governor, who shall serve as chairman;
- (d) the President of the Institute for Child Success, or his designee;
- (e) the Chairman of the Education Oversight Committee, or his designee; and
- (f) the Chairman of the Joint Citizens Legislative Committee on Children, or his designee.
