Rick-

1. Pursuant to the SC Freedom of Information Act, I respectfully request the Department to provide the following:

- a. all documents submitted to CMS regarding SC Medicaid State Plan SC 11-005 that was received by the CMS Regional Office on March 29, 2011.
- b. Attachment 4.19A of the SC state plan.
- c. The signed CMS-179 approving SPA 11-012, including the attachments thereto.

I searched the Department's website for Freedom of Information. One link appears indicating a link to the text of the FOIA. However, that page is blank. There appears to be no other information containing a contact person or division for making a FOIA request. So I make the FOIA request of you and ask you forward the request to the proper person or division if the Office of General Counsel is unable to comply with the FOIA request.

Would you also please advise me as to whether the schedule I suggested for completion of the administrative hearing in regard to Genesis Health Care, Inc. is satisfactory to you. If you recall, I suggested the following schedule:

As to dates for the hearing, there are 5 Tuesdays in April [2, 9, 16, 23, 30]. I suggest we use one of these dates for the hearing if you agree. I also suggest we agree on the language for further defining the issues for the HO by the end of January, 2013. If we are unable to agree by the end of January, then I suggest we schedule depositions for February 12, 19 or 26, 2013 [all Tuesdays]. I would think we could then all complete in one day - perhaps 1.5 days if necessary.

Finally, as to the issue of discovery, the Hearing Officer stated in an email to both of us dated August 30, 2012 which stated as follows:

Mr. Megna,

I am not denying your request for discovery. I have not yet ruled on it. It appears that the discovery Mr. Hepfer agrees to is encompassed within your Motion of Discovery. I propose that the discovery that both parties are in agreement to be allowed at this juncture.

I look forward to hearing from you so we can these matters determined. I am copying this to the Hearing Officer so she can kept in the loop for scheduling purposes.
