The Medicare Part D transition policy exists to help new enrollees get immediate access to prescription drugs within 90 days of enrollment for non-formulary drugs and medications with utilization management requirements. ## 2016 LIHEAP funds released

On Oct. 23, the Administration for Children & Families released approximately \$3 billion in Low Income Home Energy Assistance Program (LIHEAP) funds. This represented 90% of the full year funding available under the FY 2016 Continuing Resolution. The remaining monies will be released once FY 2016 funding is finalized.

- We're still waiting to hear from CMS about the final costs for Medicare Parts A & B in 2016. With no Social Security cost of living adjustment, most beneficiaries will pay the same Part B premiums (\$104.90/month) as this year, though roughly 30% of beneficiaries may pay more (those new to Medicare and with higher incomes); the Part B deductible is estimated to rise to \$167. We'll keep you posted as soon as we know more!
