Mount Pleasant Waterworks has worked cooperatively for almost 3 decades with the South Carolina Department of Health and Environmental Control (SCDHEC), the South Carolina Department of Natural Resources, the South Carolina General Assembly and the United States Geological Survey (USGS) to preserve and protect the groundwater resources in the Trident Area of South Carolina.

While Mount Pleasant does use ground water as a major resource to serve our 80,000 residents, we have worked hard to preserve and protect these resources as a reliable and sustainable supply. Therefore, we must speak up when an industry proposes to use this pristine water resource to cool machines, while we are responsible for serving human needs now and in the future. MPW replied through public comment to SCDHEC, calling for an alternative analysis to be performed to determine how other water resources could satisfy the applicant's needs.
