SECTION 1: The Minutes for the meeting of November 19, 1992; copies of which had been previously mailed to each member of the Commission were approved.

SECTION 2: The Commission unanimously passed a motion approving the monthly reports as published by the Department of activities for the month of November, 1992.

SECTION 3: The Commission unanimously passed a motion approving purchase orders issued for amounts in excess of \$10,000.00 during the month of November 1992, as shown in the Appendix.

SECTION 4: The Commission unanimously passed a motion authorizing the Department to enter into a contract with Wilbur Smith Associates for engineering services to upgrade and widen S. C. Route 101 in Spartanburg County, as shown in the Appendix.

SECTION 5: The Commission unanimously passed a motion authorizing the Department to enter into Supplemental Agreement No. 14 with Wilbur Smith Associates to extend the original Supplemental Agreements No. 4 & 11 for construction management of the first construction contract on the Scarborough Bridge (File No. 10.158A) which is part of the James Island Expressway at an estimated cost of \$194,016.00, as shown in the Appendix.

SECTION 6: The Commission unanimously passed a motion authorizing the Department to enter into Supplemental Agreement No. 1 with the City of Conway in Horry County for studies of a traffic model, preparation of environmental documents and right of way and construction plans at an estimated cost of \$500,000.00, as shown in the Appendix.

SECTION 31: On motion of Commissioner Ness, seconded by Commissioner Harrell, the Commission unanimously passed a motion adopting the following:

- (1) that the Commission direct the Department to adopt a procedure for employees to report unethical or unlawful conduct by any Department employees, contractors, consultants, vendors or any other person or company and that a poster be displayed in each Department facility throughout the State showing this information.
- (2) that a notice of the South Carolina Ethics laws, Department procedures concerning the ethics laws and the procedures for reporting unethical conduct be included in each employee's pay check.
- (3) that a letter be sent reminding each contractor prequalified to do business with the Department of the South Carolina ethics law and Department procedures concerning ethics law.
- (4) that the Department include in each prequalification packet issued to contractors a statement of the South Carolina ethics law.
- (5) that the Department issue a statement of South Carolina ethics law to each contractor at the preconstruction conference held prior to beginning work on Department contracts.
- (6) that the Department develop an ethics training program for management level employees making attendance mandatory. Each management employees will be responsible for reminding the employees under his/her supervision of the ethics law requirements.
- (7) that the Department adopt the Ethical Principles for South Carolina State Government Service and post in each Department facility a notice of the ethics principle and implement an "I Took The Pledge" campaign encouraging employees to maintain the basic principles of integrity, honesty, respect for others, fairness and accountability. This should be distributed to each employee.

- (8) that the Department develop a policy on employee dual employment, joint ownership and outside business interest in order to avoid potential conflicts of interest.
- (9) that the Department revise regulation relating to disqualifications or debarment of contractors to include the violation of the South Carolina Ethics Laws.
- (10) that the Department provide each Commissioner with a copy of SC Code Section 8-13-700.
- (11) that the Department draft and furnish a notice of a policy advising employees against providing recommendations, or advice to contractors as to purchases of equipment.
- (12) that the Department bring civil action against Thrift Brothers or any other contractor for breach of contract or for alleged overpayment in contract with the Department unless the legal division reports in writing that evidence is insufficient or some sound legal basis exists not to bring suit.

SECTION 32: On motion of Commissioner Self, seconded by Commissioner Drayton, the Commission unanimously passed a motion authorizing the Department to increase the Highway Commission budget by \$48,000.00 to utilize the services of Innovation Associates for training to create a shared vision for quality as approved by the Commission at it's meeting of October 15, 1992.

SECTION 33: On motion of Commissioner Ness, seconded by Commissioner Harvey, the Commission unanimously passed a motion adopting the following Resolution in honor of the late J. Wilton Graves:

A RESOLUTION

WHEREAS, J. Wilton Graves of Bluffton served with distinction as a member of the South Carolina House of Representatives, District 123, (1951-58, 1963-70 and 1975-82); and

WHEREAS, he served ably as a member of the South Carolina Highway Commission (1970-74), and as its Chairman (1973-74); and

WHEREAS, Mr. Graves worked tirelessly for improved transportation facilities in this State, and was particularly instrumental in getting the state to provide ferry service between the mainland and Hilton Head Island in 1953; and

WHEREAS, in 1956, he helped persuade the state to build the island's first bridge. In 1979, the bridge over Skull Creek on U. S. 278 was named in his honor; and

WHEREAS, Mr. Graves, at the age of 77, passed away on Saturday, December 12;

NOW, THEREFORE, BE IT RESOLVED that the South Carolina State Highways and Public Transportation Commission recognizes and appreciates Mr. Graves' long years of dedicated service to the people of this state, and expresses heartfelt sympathy to his widow, Mrs. Sadie Graves, and to the entire Graves family.

BE IT FURTHER RESOLVED that a copy of this resolution be sent to Mrs. Graves.

SECTION 34: On motion of Commissioner Harvey, seconded by Commissioner Chapman, the Commission unanimously passed a motion adopting the following Resolution regarding Patrol promotions:

A RESOLUTION

WHEREAS, by Resolution passed by the Commission on November 27, 1974, the Department notifies each Highway Commissioner of a respective district when certain designated promotion actions are planned with the Highway Patrol, and

WHEREAS, this implies that the Commission or individual Commissioners participate in promotions within the Patrol when such should be exclusively a matter for the final decision of the Executive Director, and

WHEREAS, such notification to the individual Commissioners constitutes an additional and unnecessary burden upon the Department, and

WHEREAS, such notification of personnel changes is not done with regard to any other division of the Department, and

WHEREAS, the Commission should concern itself with policy matters and not individual personnel matters,

NOW THEREFORE, BE IT RESOLVED that the Resolution adopted by the Commission on November 27, 1974, is hereby repealed and revoked. The Commission, the committees of the Commission, and individual Commissioners are entitled to and shall continue to receive upon request information from the Executive Director which will aid and assist them in making policy decisions and in carrying out their duties.

Contract for Engineering Services to
Upgrade and Widen S. C. Route 101
in Spartanburg County

Pursuant to the Commission's previous action of 9-17-92, authorizing the Department to seek consultant services to upgrade and widen S. C. Route 101 in Spartanburg County, the Department has entered into a contract with Wilbur Smith Associates. Work is to be funded under the STP, NHS and IM Programs.

Supplemental Agreement No. 14 with
Wilbur Smith Associates

It is recommended that Supplemental Agreement No. 14 to the Consultant Agreement dated December 3, 1976 between the Department and Wilbur Smith Associates be approved. The effect of this supplement is to extend the scope of services for construction management of the first construction contract on the Scarborough Bridge (File No. 10.158A) which is part of the James Island Expressway. These services were originally provided under Supplemental Agreements No. 4 & 11. This extension is required due to the extended construction period on this project. Due to delays and additional work, this project will extend beyond the original construction period and the contract maximum amount for the consultant services will be exceeded before the completion of construction. The amount of the extension would not exceed \$194,016.00. Funding for this work will be under the Engineering and contingency item previously allotted for this project for Charleston County.

Supplemental Agreement No. 1 with the City
of Conway - Perimeter Road Study -
Horry County

The Department requests Commission approval to enter into Supplemental Agreement No. 1 with the City of Conway for additional studies on a possible perimeter road around Conway in Horry County. The studies may include a traffic model, preparation of environmental documents and right of way and construction plans.

An environmental overview was previously performed by Parsons, Brinckerhoff, Quade and Douglas (PBQD) for the city utilizing County "C" funds. The city proposes to supplement their agreement with PBQD for this additional work, which would be funded with Federal funds since the Perimeter Road project was recently added to the Grand Strand Area Transportation Study (GSATS) and Transportation Improvement Program (TIP).

On-Call Engineering Services
Signal Systems

The Department requests Commission approval to advertise for and select consulting firms for the purpose of providing on call engineering services for the design of signal systems. With the cooperation of municipalities where appropriate, the Department anticipates contracting for the design of six traffic signal systems within calendar year 1993. The purpose of on call agreements is to expedite the design of each system.

The work in each instance will involve conducting appropriate studies to delineate subsystem limits, design each signalized intersections, design the coordination/communication routing, the control center for the system and prepare plans, special provisions for contracts and other associated tasks. The number of signals in each system will vary and be determined by the Department in cooperation with involved municipalities. Department specifications and standard/typical sheets will be used.

Funding for the design of each system will be from the same source as the planned funding for the construction of the system. Funding is expected to be NHS or STP Federal Aid Funds. The estimated sum total of design work for all six systems is \$491,000.00.

Contract for engineering services for
Southern Connector - Greenville County

Pursuant to the Commission's previous action of 3-19-92, authorizing the Department to seek consultant services to develop the Southern Connector project in Greenville County, the Department has entered into a contract with Florence & Hutcheson, Inc., in the amount of \$1,764,541.80.

Work released will complete feasibility studies, functional plans, public hearings and the draft and final environmental document.

This work will be 80% funded under the Federal Aid Innovative project and Federal Rural access projects with 20% state matching funds.
