Austin—

I have been able to sit down/talk with every senator but three: my understanding that the three who plan to speak against me are Sabb, Allen, and Bright Matthews. I spoke to Bright Matthews' paralegal yesterday at 9:15 am and offered to drive to Walterboro yesterday for even just 5 minutes with Bright Matthews, but MBM never called back. I had appeals, but Mike Campbell was going to sit in for me to enable me to make the drive. It did not happen.

Karl Allen is hostile towards me but I'll try again today.

I will try Sabb again too. He is hostile.

Don't know where Katrina Shealy is, but spoke to her Thursday and am dropping a thank you note off (for speaking to me in the lobby).

Gerald Malloy is working hard for me even though he cannot vote; he is speaking the truth about me, for which I am very grateful. I've gotten "commitments" from Scott, Jackson, Nicholson, and Johnson. I think Kent Williams is now OK with me. After a 30 minute conversation, Kimpson said he accepted what I said at face value and would not block my reappointment. However, he hinted that there would be a motion to carry over.

Everyone else to my knowledge is OK with me; I have talked to every senator personally except for Sabb. The Allen and Bright Matthews encounters were brief and not helpful. My letter to Bright Matthews explaining how I was willing to drive to Walterboro to see her may or may not help.

Because nothing else "stuck" in the subcommittee/committee, the racism lies are largely what remain. The Commission's "tracking" system (whereby only hearings transcribed are "counted") allows Hood & Co. to say I don't work. To give you an idea: I had 4 hearings on Friday (1 of which was not on the record). On Friday night, I reviewed the evidence for one and wrote the decision. On Saturday, I did the same for the 2nd one. I started the 3rd one on Sunday, but had to review my appeals for Monday. I also signed fee petitions last night for an hour.

BTW, all the other senators have been very positive.

Hope this is what you're looking for. Do you know if this is being taken up today?
