A regular meeting of County Council of Charleston County was held on the 4th day of June, 2013, in the Beverly T. Craven Council Chambers, Second Floor of the Lonnie Hamilton, III Public Services Building, located at 4045 Bridge View Drive, Charleston, South Carolina.

Present at the meeting were the following members of Council: Teddie E. Pryor, Sr., Chairman, who presided; Colleen Condon; Anna Johnson; Joseph K. Qualey; A. Victor Rawl; Herbert R. Sass, III; and Dickie Schweers. Council Member Henry E. Darby; was ill and unable to be present. Council Member J. Elliott Summey was out of town and absent.

Also present were County Administrator W. Kurt Taylor and County Attorney Joseph Dawson.

Rev. Robert Reid gave the invocation and Deputy Administrator for Finance, Keith Bustraan, led in the pledge to the flag.

The Clerk reported that in compliance with the Freedom of Information Act, notice of meetings and agendas were furnished to all news media and persons requesting notification.

Mr. Sass moved approval of the minutes of the May 21, 2013 County Council meeting, seconded by Ms. Johnson, and carried.

The Chairman requested Jim Neal, Director of Public Works and County Administrator. A report was read from the Finance Committee under date of June 4, 2013 that it considered the information furnished by County Administrator Kurt Taylor and Charleston County Coroner Rae Wooten regarding the graves of thirty-seven individuals discovered at the Gaillard Auditorium construction site in downtown Charleston in February, 2013. It was stated that the graves are believed to date to the 1720s or 1730s and the City of Charleston's Forensic Archeologist and the Charleston County Coroner's Office Forensic Anthropologist are working together to forensically analyze all of the remains. It was further stated that the Charleston County Coroner's Office, and in particular the services and expertise of the Forensic Anthropologist employed by the Coroner's Office, has been requested by the City of Charleston to conduct forensic analysis and research on the thirty-seven recovered remains to include demographic data, social data and health data, with the City of Charleston agreeing to cover all of the associated expenses incurred by the Coroner's Forensic Anthropologist to include time and supplies. In addition the City of Charleston has asked that the Forensic Anthropologist's preliminary report be complete by August 31, 2013 however we would request that reimbursements be accepted until December 31, 2013 should they request additional services after receiving the preliminary report and these expenses are anticipated to total approximately \$15,000.00.

Committee recommended that Council authorize the Coroner's Office to accept approximately \$15,000.00 in reimbursement funds from the City of Charleston for expenses incurred by its Forensic Anthropologist in conducting forensic analyses until December 31, 2013 for the thirty-seven sets of remains recovered from the Gaillard Auditorium construction site, with the understanding that there are no FTEs, matching funds, re-occurring costs, or any ongoing commitment for the County associated with this request.

A report was read from the Finance Committee under date of That it considered the information furnished by County Administrator Kurt Taylor and Emergency Management Director Jason R. Patno regarding the Awendaw Consolidated Fire District request to accept \$5,000 in Volunteer Fire Assistance (VFA) grant funding from the South Carolina Forestry Commission under the USDA Forest Service's National Fire Plan (NFP) Program. It was stated that the intent of the VFA/NFD Program is to assist rural volunteer fire departments in purchasing wild land firefighting equipment to use against wild land fires that threaten the rural developments and communities they serve. It was further stated that the grant funds will be used to reimburse the Awendaw Consolidated Fire District for 1) a Ford F550 service/utility truck, 2) a skid unit with a 250 gallon holding tank, 3) and a 150 GPM pump. If approved, the grant funding will be used to offset the costs that have already been incurred for these items.

Committee recommended that Council approve the Awendaw Consolidated Fire District's request to receive funding in the amount of \$5,000 in Volunteer Fire Assistance (VFA) grant funding from the South Carolina Forestry Commission under the USDA Forest Service's National Fire Plan (NFP) Program. with the understanding that Matching funds are not required; that there are no FTE's or PTE's associated with the receipt of the above referenced funds and the grant performance period is April 1, 2012 to March 31, 2013.

A report was read from the Finance Committee under date of May 30, 21013 that it considered the information furnished by County Administrator Kurt Taylor and Greenbelts Program Director Cathy Ruff regarding the urban greenbelt project listed

below which has been reviewed by the Urban Grants Review Committee and the Charleston County Park and Recreation Commission (CCPRC).

The CCPRC is recommending approval of the following project.

It was stated that the City of North Charleston is requesting a portion of their urban greenbelt funds to purchase this .14 acre parcel located on O' Hear Avenue near Noisette Creek. It was shown that two vacant buildings currently exist on the property; and the City plans to demolish the structures soon after acquisition to combine this property with adjacent Greenbelt properties to provide residents' access to Noisette Creek and its marsh. It was further shown that the City of North Charleston currently has \$2.53 million remaining of their urban greenbelt funds allocation and the Urban Grants Review Committee unanimously approved the 4286 O' Hear project at their May 2, 2013 meeting.

Committee recommended that Council:

1. Approve funding for the urban greenbelt project, provided that upon approval, grant agreements will be executed between the County and appropriate parties.
2. Authorize the County Administrator to require the execution and delivery of proper agreements and instruments to implement the conditions of the approval of the grant funds, and to effectuate the goals of the Greenbelt Program ordinances and policies.
3. Approve the use of \$29,200 to be funded from a combination of Greenbelt Operating Contingency and/or 2011 General Obligation Bonds.

Ms. Johnson requested that these items be voted on separately. The request was granted.

Mr. Rawl moved approval of the Urban Greenbelt Project, seconded by Mr. Sass, and carried unanimously.

The Chairman called for a vote on the Rural Greenbelt Project. Mr. Rawl moved approval, seconded by Mr. Sass and carried. Ms. Johnson and Mr. Pryor voted nay.

A report was read from the Finance Committee under date of May 30, 2013 that it considered the information furnished by County Administrator Kurt Taylor and Assistant Administrator for Transportation Development and Public Works Jim Armstrong regarding utilization of the approved Objective Evaluation and Prioritization process to create a prioritized list of projects to be funded by FY 2014 Annual Allocation funds from the Transportation Sales Tax. The list includes carryover projects and new requests within each Allocation Category. It was stated that Council is requested to approve the prioritized lists and the resulting recommendation within each category so that staff may continue the development of the requested projects. It was shown that staff is managing four large allocation projects which currently have a significant funding shortfall. They are:

It was further shown that, using the historic approved funding levels per category for allocation projects, it would take at least five years to secure enough funding to construct these projects with the cost to construct escalating over time, and in an effort to expedite their completion, staff is requesting approval to expend bond funds now and reimburse these bond funds with allocation funding as it becomes available over the next several fiscal years. This also will assist in meeting the obligation to expend a required percentage of bond funds within the specified period of time.

Committee recommended that Council:

1. Approve the list of prioritized projects which were developed through the use of the Objective Evaluation and Prioritization Process, to be funded by the Annual Allocation funds of the Transportation Sales Tax for Fiscal Year 2014.
2. Approve expending bond funds to complete the projects in the attached table with reimbursement to come from allocation funds. It is anticipated that the bond funds will be reimbursed within five years based on historic allocation funding levels.

Mr. Rawl moved approval of the projects, seconded by Mr. Sass.

A request to vote on the projects separately was made and approved.

The Chairman called for a vote on the IOP Connector Widening & Rifle Range Intersection Improvement. The vote was unanimously in favor. Council Members Darby and Summey were absent

A vote on the Ashley River Bridge Retrofit was called and carried. Mr. Sass and Mr. Rawl voted nay. Messer Darby and Summey were absent.

A vote of approval on the SC 61 @ SC 7 Intersection carried unanimously. Council Members Darby and Summey were absent.

The fourth Project, the James Island Connector / Calhoun Street at Courtenay Drive was voted on and carried unanimously. Messer Darby and Summey were absent.

A report was read from the Finance Committee meeting of May 30, 2013 that it considered the information furnished by County Administrator Kurt Taylor and County Council Chairman Teddie Pryor regarding a request to amend the Ordinance dealing

with Charleston County Bar Time Closing. It was stated that this request was being made so that Charleston County's Ordinance would be in conformity with Municipal Ordinances in Charleston County.

Committee recommended that Council approve and give first reading to an Ordinance amending Charleston County's Bar Closing Ordinance.

Ms. Johnson moved approval of Committee recommendation, seconded by Mr. Qualey and carried.

An Ordinance amending Charleston County's Bar Closing Ordinance was given first reading by title only.

AN ORDINANCE

AMENDING SECTION 13-3 OF THE CHARLESTON COUNTY CODE OF ORDINANCES SO AS TO PROHIBIT THE OPERATION OF COMMERCIAL ESTABLISHMENTS ALLOWING ON PREMISES CONSUMPTION OF BEER, ALE, PORTER, WINE OR ALCOHOLIC LIQUORS BETWEEN THE HOURS OF 2:00 AM AND 6:00 AM.

The Ordinance in its entirety will appear in the minutes of Charleston County at the time of third reading.

Council Comments

The Chairman asked if any Member of Council wished to bring a matter before the Body.

Mr. Schweers said that this is his 7th budget and the best we have had during this time, and thanked Staff. He said he did not understand why it was necessary now to increase millage when the financial picture has been so bleak in the past.

Mr. Schweers asked "Why in an expanding economy, it was necessary for Council to increase millage?"

Ms. Johnson thanked Staff for their hard work on the budget

Ms. Condon stated that she thinks "Tax Payers" will appreciate their tax bills being lower.

Mr. Sass stated:

For the record. The four projects, Isle of Palms and especially the Ashley River Bridge, I think these are good projects. The Ashley River Bridge project, I have objections too and have deep concerns about because of the amount of money we are spending. I got a number of phone calls today about it. All but one of them was not in favor of it. What I'm concerned about is we know that it is feasible to do this but the Highway department can come back later and tell us that it's not feasible anymore.

I'm even more concerned if I read this information I got correctly today, that the morning drive on the bridge now is a level of service C and when we go down to 3 lanes, it will be a D, if I'm reading that right, Mr. Thigpen? Ms. Turner? That does concern me. I think what is going to happen is I think the public hasn't paid attention to this. I think as soon as they see those cones out there on the bridge, there is going to be a huge cry and not

only that taking 18 months to do this project concerns me. I'd like to find a different way to do it. I know it's been looked at but I'm just not in favor of it, and that's why I just want to go on record.

County Administrator Kurt Taylor thanked Council for approving the budgets and introduced his parents Laura and Guy Taylor who were in the audience.

The Chairman said that he felt Council owed it to the Citizens to provide the services that they need.

There being no further business to come before the Body, the Chairman declared the meeting to be adjourned.
