David,

I have attached a document sent to me and several interested homeowners on April 13, 2016, one year after the permit had been approved. This hardly qualifies as proper notice and as you can see it does not include information on right to appeal the DHEC decision. I have sent you conclusive evidence that no notification exists showing any of the adjacent landowners were afforded any notification providing us the opportunity to oppose the approval of the permit. These are serious allegations against OCRM in connection with this application. All that we want is for OCRM to realize that the fundamental purpose of providing "notice to interested parties" did not occur with this application, so the relief that we request for suspension and/or revocation of the permit is the only reasonable way to proceed. OCRM has either been duped by or is in concert with the realtors(Carolina One and Peter Kuhns) who are the only parties to gain from building this boardwalk/dock and destroying our beautiful marsh. We are appealing to Governor Haley to intervene on behalf of the homeowners. Please let me know what our process should be to stop this dock from being built.
