We would like to hold a press conference at the
Governor's office next week. Included in the event
would be:

- Nikki Haley, Governor of South Carolina

Of these listed, we would expect only the Governor and the Commissioner to speak. The key points to be addressed in the presentation are:

- Agriculture and forestry together make up the state’s largest industry.
- Cash recipients for agricultural commodities are up 54% since 2006.
- The Agribusiness Cluster has a total economic impact of \$41.7 billion in 2013, with \$26.8 billion in direct output.
- Economic impact has increased 23% since 2006.
- Agribusiness was responsible for 9.1% of economic activity in the state of South Carolina.
- The Agribusiness Cluster accounted for 109,141 direct jobs and a total employment of 212,530 jobs, representing 10.5% of the state’s workforce.

Our recommendation is to hold the event on either Monday, 2/2 or Friday, 2/6 if the Governor’s availability permits.
