These funds will help support Leadership South Carolina's newly created Diversity Scholarships and Programming.

Leadership SC is VETO 32 - which reads in part:

VETO 32 – Part1B, Page 501, Section 118, Statewide Revenue - Proviso 118.16(B), Item 46(c), Department of Administration, State Human Resources, Leadership South Carolina: \$150,000.

From the creation of our organization, LSC was provided for via state funding from 1979 to 2003 with state appropriations ranging from \$200,000 to \$300,000 annually.

We have not received any state funding since that time, yet are committed to insuring that leadership development occurs throughout the state.
