Dear Mr. Keck:

Article III, paragraph D. of the contract between the Office of the State Auditor and the South Carolina Department of Health and Human Services requires the Office of the State Auditor to examine nursing facilities once every four years. In addition, the Office of the State Auditor also uses the following criteria to select the engagements.

- Results of prior work
- Results of cost report analyses
- A provider's entry into or departure from the Medicaid program
- Results of ongoing work of related providers
- Appropriate referrals or requests
- Experience factors

The following identifies the engagements that we plan to conduct during federal fiscal year 2013.

I. Nursing Homes – In most instances the latest filed cost report will be selected and the prior cost report will also be selected if the ongoing work indicates the probable existence of material findings. We will first complete all engagements that were scheduled and/or in-progress during the prior year. 
