Without my Parent or Legal Guardians Present or Consent, I Was Transferred Across state LINE to the state of South Carolina. I Was turned over to the Dillon County police Department. The arresting officer Mr. CLIFF Arnette, placed me under Question about a crime I Never committed. I asked Mr. CLIFF Arnette Could I please Contact my parent or AN Attorney. I Was Denied this right to Legal Counsel and my Parent. I Was Interrogated and Accused Without the presence of my parent of committing; Armed Robbery, Assault & Battery with, Possession of a Firearm, and Attempted Robbery. Mr. CLIFF Arnette Informed me I Was Not allowed to Contact my Family unless, I admitted to ~~the~~ committing the crimes at that moment, or I would Receive 75 to 90 years In Prison. So Under threat, Duress, and Coercion of OFC. CLIFF Arnette. I Was Scared For my life. I Was forced to Admit to a Crime I did not commit. I Was then presented With a written statement By Mr. CLIFF Arnette to Sign Without my parents ~~or~~ Attorney present. Later my public Defender Mr. Jeffords Legette who misrepresented Information to me. Which make him InEffective →

The prosecutor in the case was Mr. Kenard Redman; he previously Represented me In a civil action Approximately six (6) years prior. He Never Informed the courts of this fact, which makes It a conflict of interest. 7 months after my Arrest on May 17, 2004 Mr. Kenard Redman & Mr. Lefon Legette both Coerced me to Sign at 16 year old a Negotiated Plea Agreement Contract for (12) twelve years In prison, under, threat, Duress, and Coercion. Without my Parent present Mr. Kenard Redman stated that I was not allowed to speak with my parent, and, she was not allowed to be present at the contract signing of a Negotiated Plea Agreement. This act was an Unlawful Plea Bargain, Because ~~my~~ I was a minor who had Know Rights ~~at~~ the age of (16) sixteen years old. That's a violation of the Rules of Contracting with a minor. you must have Parental Consent. The United States Constitution, and the United States Codes Annotated Title Eighteen (18) Crimes have been committed against me. my 5th, 6th, 13th, and 14th Amendments. In the Constitution (Bill of Rights) which was enforced on December 15, 1791 has been violated. I've been kidnapped, and held hostage by the South Carolina Government for (11) years (6) months under a Unlawful Invalid → Plea Agreement.

I've Been held IN Captivity as a hostage With Bipolar mental health Disorders For over 11 years I Want Justice. I WAS taken Advantage of As a 16 year old minor With a mental Health Disorder of Bipolar. I've Been off Several Different psycotropic, ~~and~~ and Anti Depresses. Medication

I am Forever Traumatized By Being Forced into Slavery at the Age of a minor. meaning my 13th Amendment has Been Violated.
